

1 **Section 4. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or
2 word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adju-
3 dication shall not affect the remaining portions of this resolution, which shall remain in full force and effect
4 as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the reso-
5 lution.

6 **Section 5. Repealer.** All laws, ordinances and resolutions, or parts of the same, that are inconsistent
7 with the provisions of this resolution, are hereby repealed to the extent of such inconsistency including, but
8 not limited to, Little Rock, Ark., Resolution No. 14,451 (November 15, 2017).
