8	<b>REBSAMEN PARK ROAD CULVERT REPAIR PROJECT; AND FOR</b>
9	OTHER PURPOSES.

11	WHEREAS, bids were solicited for the replacement of a collapsed and failing section of storm sewer
12	on Riverfront Drive at Rebsamen Park Road, Bid No. 1250; and,
13	WHEREAS, Cisneros Family Construction Corporation, was the lowest responsive, responsible bid
14	meeting specifications.
15	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
16	OF LITTLE ROCK, ARKANSAS:
17	Section 1. The City Manager is hereby authorized to execute an agreement with Cisneros Family
18	Construction Corporation, for the Riverfront Drive at Rebsamen Park Road Culvert Repair Project in an
19	amount not to exceed One Hundred Sixty-One Thousand, Nine Hundred Fifty-Three and 68/100 Dollars
20	(\$161,953.68), which is the base bid amount of One Hundred Thirty-Four Thousand, Nine Hundred Sixty-
21	One and 40/100 Dollars (\$134,961.40), plus 20% contingencies.
22	Section 2. Funding for this project is to be funded as a Street Fund Special Project from the State Sales
23	Tax Turn-Back.
24	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
25	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
26	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
27	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
28	resolution.
29	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
30	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
