

## INSTRUCTIONS FOR MAKING APPLICATION FOR A LAND USE AMENDMENT

- 1. The applicant (owner or authorized agent) shall submit completed application forms and present filing fee at the Department of Planning and Development, 723 West Markham.
- 2. The applicant shall submit as part of the application a (24" X 36") hardcopy or a PDF (or other approved format) of a plan including the following information:
  - 1. Area plan to scale
  - 2. Property Boundaries
  - 3. Proposed Land Use designations
  - 4. Legal Description
  - 5. Scale
  - 6. North arrow
  - 7. Vicinity map
  - 8. Adjacent Street Names shown
  - 9. Street Address of Property
- 3. A filing fee as prescribed by ordinance shall be paid no later than the published docket closing date. Applicant shall post sign(s) per placement dictated by staff at least 15 days prior to the public hearing.
- 4. If application is being made by an agent of the owner(s), an additional separate form "Authorization of Representation Statement" will be required for each owner.

## **Please Note:**

- a) Submission of an incomplete application or noncompliance with the above may cause your application to be withheld and not considered at the meeting and may require the payment of an additional filing fee.
- b) Staff advice as to the land use classification to be utilized does not constitute a recommendation of approval of the application. Staff recommendations are based on field inspections, plans for the areas, reports from other departments and other information.

**NOTE:** Please check with the Planning Staff for the appropriate fee and filing date for the Planning Commission Public Hearing.
