NARRATIVE

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A THEFT JUST OCCURRED. OFFICERS ARRIVED ON SCENE MADE CONTACT WITH MS. PARIS, MS. HAGINS, MR. WANG.

MS. PARIS STATED A BLACK MALE HAD GONE INSIDE THE STORE WITH A BEER CAN IN HIS HAND AND MS. PARIS ADVISED THE BLACK MALE HE COULD NOT HAVE THAT INSIDE THE STORE. MS. PARIS STATED THE BLACK MALE CONTINUED TO WALK INTO THE STORE AND WAS HEADING TOWARD THE SUNGLASSES ISLE. MS. PARIS STATED THEY HAVE VIDEO OF THE BLACK MALE PUTTING THE SUNGLASSES IN HIS POCKET. MS. PARIS STATED THE BLACK MALE WAS USING PROFANITY LANGUAGE TOWARD THE EMPLOYEES. MS. PARIS STATED SHE DID NOT RECOGNIZE THE BLACK MALE. MS. PARIS STATED THE BLACK MALE STARTED WALKING WESTBOUND ON 12TH STREET. MS. PARIS STATED THE BLACK MALE WAS WEARING A RED AND WHITE JUMP SUIT.

MS. HAGINS STATED SHE WAS WALKING TOWARD THE BLACK MALE ASKING HIM TO GIVE BACK THE SUNGLASSES. MS. HAGINS STATED THE BLACK MALE KEPT SAYING "BITCH COME OUTSIDE AND IMA POP YOU". MS. HAGINS STATED THE BLACK MALE DID NOT STOP AND CONTINUED TO WALK OUT THE FRONT DOOR WITH THE UNPURCHASED ITEM(S) IN HIS POCKET. MS. HAGINS STATED THEY DID NOT RECOGNIZE THE BLACK MALE.

MR. WANG STATED HE STARTED WALKING TOWARD THE BLACK MALE ASKING HIM TO GIVE BACK THE SUNGLASSES. MR. WANG STATED HE DID NOT RECOGNIZE THE BLACK MALE.

OFFICERS OBSERVED THE TIME STAMP VIDEO WHEN THE BLACK MALE TOOK THE SUNGLASSES AROUND 1633 HOURS. OFFICERS GAVE MS. PARIS AN INCIDENT REPORT CARD. OFFICERS CIRCULATED THE AREA WITH NEGATIVE RESULTS. MVR/BWC IN USE 18C475
