**A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO AWARD A CONTRACT TO CLIFF CHILDRESS CONSTRUCTION, IN AN AMOUNT NOT TO EXCEED EIGHTY-TWO THOUSAND, EIGHT HUNDRED DOLLARS (\$82,800.00), FOR THE COLONEL GLENN/TIMBERLAND DRIVE DRAINAGE IMPROVEMENT PROJECT; AND FOR OTHER PURPOSES**

**WHEREAS**, Bids were solicited for the Colonel Glenn/Timberland Drive Drainage Improvement Project, Project No. 16-7-DR-23, Bid No. 18022; and,

**WHEREAS**, Cliff Childress Construction was the lowest responsive, responsible bid meeting specifications.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS:**

**Section 1.** The City Manager is hereby authorized to execute an agreement with Cliff Childress Construction for Colonel Glenn/Timberland Drive Drainage Improvements in an amount not to exceed Eighty-Two Thousand, Eight Hundred Dollars (\$82,800.00), which is the base bid amount of Sixty-Nine Thousand Dollars (\$69,000.00) plus 20% contingencies.

**Section 2.** Funding for this project is from the ¾-Cent Capital Improvement Sales and Compensating Use Tax Funds as authorized by Resolution No. 14,310.

**Section 3. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the resolution.

**Section 4. Repealer.** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
