NARRATIVE

AT APPROXIMATELY 1149 HOURS, OFFICERS RESPONDED TO A SHOTS FIRED CALL AT 2310 HOWARD. PULASKI COUNTY SHERIFF'S OFFICE ADVISED A MALE SUBJECT CALLED ADVISING HE WAS TALKING ON THE PHONE TO A FEMALE WHO LIVES AT THIS LOCATION, AND HEARD A GUN SHOT. WHEN OFFICERS ARRIVED MULTIPLE SUBJECTS WERE OUTSIDE THE HOUSE ADVISING THEY HEARD SOMETHING HAPPENED, BUT DIDN'T KNOW WHAT. A BLACK MALE ADVISED HE CALLED POLICE, AND CAME OVER BUT NO ONE IS HOME. THE SUBJECT THEN LEFT. OFFICERS LOCATED 1 SHELL CASING AND BLOOD ON THE DRIVEWAY. OFFICES SET UP A CRIME SCENE. OFFICER AGAIN STARTED TO CHECK THE RESIDENCE, AND 2 SUBJECTS CAME TO THE FRONT DOOR (JUVENILE SUSPECT, AND HIS MOTHER TIFFANY GRAYS), BOTH SUBJECTS WERE DETAINED. IN THE MEANTIME JUVENILE VICTIM SHOWED UP TO THE CHILDREN'S HOSPITAL ER WITH HIS MOTHER (LAVONDA GRAYS). JUVENILE VICTIM ADVISED HE WAS ACCIDENTALLY SHOT BY HIS COUSIN (JUVENILE SUSPECT) AT HIS HOUSE ON HOWARD. DETECTIVES LOCATED A BACKPACK WITH A FIREARM IN THE BACK YARD OF THE RESIDENCE. JUVENILE SUSPECT WAS TRANSPORTED TO THE 12TH STREET DETECTIVE'S OFFICE. TIFFANY RESPONDED TO THE 12TH STREET DETECTIVE'S OFFICE. AFTER DETECTIVE INTERVIEWS THE INCIDENT WAS DETERMINED TO BE AN ACCIDENTAL SHOOTING AT THIS TIME. ALL PARTIES WERE RELEASED WITHOUT CHARGES AT THIS TIME. JUVENILE VICTIM WAS ADVISED TO BE IN STABLE CONDITION AT THIS TIME. THE BACKPACK AND FIREARM WERE STORED AT THE 12TH STREET PROPERTY ROOM. MVR WAS IN USE, BUT STOPPED WORKING DUE TO THE BATTERY POWER FAILING DURING THE CALL 21C672 1X52.

NARRATIVE

OFFICERS WERE DISPATCHED TO A ROBBERY OF AN INDIVIDUAL. UPON ARRIVAL, OFFICERS OBSERVED A BLACK MALE GO INTO AN APARTMENT ACROSS THE STREET FROM THE RESIDENCE. OFFICERS MADE CONTACT WITH THE VICTIM, GREG CAERY, MR.CAERY ADVISED THAT HE WAS WALKING THROUGH THE APARTMENT WHEN HE BUMPED INTO THE SUSPECT. MR. CAERY STATED THAT THE MALE THEN BEGAN TO FOLLOW HIM TOWARD HIS RESIDENCE. MR. CAERY ADVISED WHEN HE WAS AT THE EDGE OF HIS DRIVE WAY HE TURNED AROUND AND ASKED THE SUSPECT WHAT HE WANTED. THE SUSPECT PRODUCED A BLACK HAND GUN AND HELD IT UP TO HIM AND SAID "EMPTY YOUR POCKETS." AT THIS TIME THE SUSPECT WALKED OUT OF 6415 WEST 3RD STREET APARTMENT 2. OFFICERS APPROACHED THE MAN AND PLACED HIM INTO CUSTODY AND DID A PAT DOWN FOR SAFETY REASONS. OFFICERS IDENTIFIED THE SUSPECT AS, BRIAN COLEMAN. OFFICERS MADE CONTACT WITH MR. COLEMANS MOTHER, TRENA COLEMAN, AT HER RESIDENCE. MS. COLEMAN ADVISED THAT MR. COLEMAN STAYED THERE ON THE COUCH. OFFICERS ASKED IF THEY COULD LOOK AROUND THE COUCH FOR ANY EVIDENCE. MS. COLEMAN ADVISED THAT THEY COULD. OFFICERS ENTERED THE RESIDENCE AND LOCATED A BLACK HANDGUN UNDER A BLANKET ON THE COUCH. OFFICERS ALSO LOCATED MULTIPLE MARIJUANA CIGARS. OFFICERS ALSO LOCATED A BOTTLE OF GREEN LIQUID WITH A LOW VISCOSITY SIMILAR TO COUGH SYRUP. AFTER THESE ARTICLES OF CONTRABAND WERE DISCOVERED OFFICERS SEARCHED MR. COLEMAN FOR OFFICER SAFETY AND LOCATED A RECEIPT CONTAINING A SMALL AMOUNT OF GREEN VEGGIE MATTER. OFFICERS THEN NOTIFIED A NORTHWEST SUPERVISOR OF THEIR FINDINGS, OFFICERS THEN CONTACTED A DETECTIVE SERGEANT. THE DETECTIVES ON DUTY STATED THERE WERE NO INDEPENDENT WITNESSES OR VIDEO FOOTAGE COOBERATING MR. GAERYS STATEMENT OF EVENTS. OFFICERS AGREED WITH THIS. OFFICERS SPOKE TO MR. GAERY WHO WAS UNDERSTANDABLY UPSET WITH THIS COURSE OF ACTION. MR. GAERY WANTED A SUPERVISOR TO RESPOND TO THE SCENE. OFFICERS CONTACTED K30 TO RESPOND. MR. GAERY WAS PROVIDED WITH ALL OFFICERS AND SUPERVISORS NAMES AND EMPLOYEE NUMBERS UPON HIS REQUEST. MR. OFFICERS RESPONDED CODE 3 STATUS TO THE LISTED LOCATION IN REFERENCE TO A SHOOTING. UPON ARRIVAL, CONTACT WAS MADE WITH MR. GABRIEL GEE WHO HAD AN APPARENT INJURY TO THE HEEL OF HIS RIGHT FOOT AFTER BEING GRAZED BY A BULLET THAT HAD ENTERED HIS HOME. MR. GEE ADVISED HE WAS LAYING DOWN IN HIS BEDROOM WHEN HE HEARD SEVERAL GUNSHOTS OUTSIDE AND OBSERVED THEM ENTER THE HOME. MR. GEE FELT A BULLET GRAZE HIS FOOT BEFORE HE GOT UP TO CHECK ON HIS THREE CHILDREN (JUV1, JUV2, AND JUV3), WHO WERE UNHARMED, AND CALLING 911. MR. GEE WAS EVALUATED BY FIRE DEPARTMENT PERSONNEL ON SCENE AND REFUSED TRANSPORT BY AMBULANCE. JUV1 ADVISED OBSERVING A "LARGE WHITE PICKUP TRUCK" SPEEDING OFF FROM THE AREA AFTER THE GUNSHOTS STOPPED. OFFICERS OBSERVED SEVERAL STRIKE MARKS ON THE INSIDE AND OUTSIDE OF THE RESIDENCE, AS WELL AS DAMAGE TO VEHICLE 1 AND A WASHING MACHINE IN FRONT DRIVEWAY. MR RIOS ADVISED HE WAS AT 5001 W 65TH MEETING A FRIEND ON THE WEST SIDE OF BUILDING E WHEN HE WAS ROBBED AT GUNPOINT. HE ADVISED 3 BLACK MALES PULLED HIM OUT OF VEHICLE-1 AT GUNPOINT. MR RIOS ADVISED HE BROKE AWAY AND BEGAN RUNNING NORTH TOWARDS THE ENTRANCE OF THE COMPLEX WHEN HE HEARD TWO GUN SHOTS. MR RIOS ADVISED HE DIDN'T KNOW IF THEY WERE SHOOTING AT HIM OR UP IN THE AIR BECAUSE HE WAS RUNNING AWAY. MR RIOS ADVISED HE LEFT 5001 W 65TH AT THIS TIME. MR RIOS CALLED 911 FOR A REPORT THIS MORNING AT 0901 HOURS. A SUPERVISOR AND MAJOR CRIMES DETECTIVE WERE NOTIFIED AT THIS TIME AND AN INCIDENT CARD WAS GIVEN TO MR RIOS. OFFICERS RESPONDED TO 5001 W 65TH IN SEARCH OF SHELL CASINGS WITH POSITIVE RESULTS (FINDING FOUR .380 SHELL CASINGS AT THE AREA OF WHERE MR RIOS ADVISED HE WAS ROBBED.) NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A ROBBERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE EMPLOYEES OF THE BUSINESS, MR. FARSHATIA AND MR. REDDY.

MR. FARSHATIA ADVISED HE OBSERVED A HISPANIC MALE WEARING ALL BLACK CLOTHING AND A "COVID MASK" ENTERING THE PLACE OF BUSINESS. MR. FARSHATIA FURTHER ADVISED THE UNKNOWN HISPANIC MALE APPROACHED THE REGISTER AND STATED, "GIVE ME THE MONEY, I HAVE A GUN". MR. FARSHATIA ADVISED HE OBSERVED A GUN SHAPE SILHOUETTE OBJECT FROM THE PANTS OF THE UNKNOWN HISPANIC MALE. MR. FARSHATIA ALSO ADVISED THE UNKNOWN HISPANIC MALE NEVER POINTED THE WEAPON AT HIM. MR. FARSHATIA ADVISED THE HISPANIC MALE APPROACHED THE INSIDE OF THE COUNTER AND PROCEEDED TO TOUCH THE REGISTER AND TAKE AN ESTIMATED 900 DOLLARS. MR. FARSHATIA ALSO ADVISED WHEN THE HISPANIC MALE WAS ABOUT TO LEAVE THE PLACE OF BUSINESS HE STATED, "I'LL COME BACK AGAIN". MR. FARSHATIA ADVISED THE HISPANIC MALE LEFT IN AN UNKNOWN VEHICLE GOING WESTBOUND ON THE SERVICE ROAD NEXT TO THE INTERSTATE ROAD. OFFICERS ALSO MADE CONTACT WITH MR. REDD WHO ADVISED HE ONLY OBSERVED A SUBJECT WEARING ALL BLACK. MR. REDD ADVISED HE DID NOT SEE A GUN AND HE WAS NOT THREATED BY THE UNKNOWN HISPANIC MALE.

NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION FOR A ROBBERY CALL. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE VICTIM, KYUNG KIM, WHO ADVISED OF A BLACK MALE AND A BLACK FEMALE THAT HAD ENTERED HER STORE. OFFICERS WERE HAVING DIFFICULTIES UNDERSTANDING HER DUE TO A LANGUAGE BARRIER AND WERE ABLE TO HAVE HER SON, BRIAN KIM, TRANSLATE FOR OFFICERS. HE ADVISED OF THE FOLLOWING FROM MS. KIM.

SHE ADVISED THAT THE TWO SUBJECTS PROCEEDED TO GRAB HANDFULS OF MERCHANDISE AND SHE ADVISED THEM TO STOP AND TO LEAVE THE STORE WITHOUT ANY ITEMS. SHE ADVISED THAT THE MALE DROPPED HIS ITEMS AND LEFT THE STORE, BUT THE FEMALE REMAINED INSIDE.

MS. KIM ADVISED THAT SHE PROCEEDED TO LOCK THE DOOR OF HER BUSINESS AND TOLD THE FEMALE TO LEAVE THE ITEMS AS SHE WOULD NOT LET HER PAY FOR THE ITEMS. MS. KIM ADVISED THAT SHE UNLOCKED THE DOOR TO ALLOW A CUSTOMER TO ENTER AND THE FEMALE PROCEEDED TO LEAVE THE STORE AT THIS TIME WITH THE LISTED MERCHANDISE. SHE ADVISED THAT THE FEMALE WENT TO A BLUE TOYOTA HIGHLANDER (AR LPN DB069857) WITH THE MALE IN THE DRIVER'S SEAT. SHE ADVISED THAT SHE ATTEMPTED TO RETRIEVE HER ITEMS FROM THE SUSPECTS AND WAS PUSHED BY THE MALE, CAUSING HER TO HIT THE GROUND. SHE ADVISED THAT SHE SUSPECTS FLED THE AREA IN AN UNKNOWN DIRECTION AT THIS TIME.

OFFICERS OBSERVED INJURIES TO MS. KIM'S LEFT ARM AND RIGHT HAND, BUT SHE REFUSED MEDICAL ATTENTION ON SCENE AFTER BEING ADVISED THAT SHE WOULD BE ABLE TO RECEIVE ATTENTION.
