JUV#1 THEN ENTERED A SOUTH FACING ROOM TO LOOK FOR A LIGHTER. MS. RATLIFF ADVISED JUV#1 STATED HIS FATHER, SUSP#2(MONTGOMERY), USUALLY KEEPS A LIGHTER IN THAT ROOM. MS. RATLIFF ADVISED SHE HEARD A LOUD POP AFTER JUV#1 ENTERED THE ROOM. MS. RATLIFF STATED SHE WENT INTO THE ROOM AND OBSERVED JUV#1 STANDING IN FRONT OF A DRESSER. MS. RATLIFF ADVISED JUV#1 APPEARED TO BE IN SHOCK. MS. RATLIFF GRABBED JUV#1 AND BROUGHT HIM INTO THE KITCHEN WHERE SHE OBSERVED THE GUN SHOT WOUND. MS. RATLIFF ADVISED SHE CALLED 911 AND JUV#1S MOTHER, SUSP#3(BARAWI).

NEITHER MR. MONTGOMERY OR MS. BARAWI WERE ON SCENE AT THE TIME OF THE SHOOTING.

NARRATIVE

OFFICERS FAIRCLOTH, HALL, AND SILVA WERE ADVISED BY ARKANSAS STATE POLICE THAT THE SUSPECT VEHICLE IN AN AGGRAVATED ROBBERY THAT OCCURRED ON 04/14/2024 WAS LOCATED AT 8622 CHICOT ROAD.

PEREZ AND GUTIERREZ WERE BOTH TRANSPORTED TO THE 12TH STREET SUBSTATION FOR FURTHER INVESTIGATION. ONCE INVESTIGATION WAS COMPLETE PEREZ WAS TRANSPORTED TO THE PULASKI COUNTY REGIONAL JAIL WHERE HE WAS CHARGED WITH AGGRAVATED ROBBERY AND THEFT OF PROPERTY. GUTIERREZ WAS TRANSPORTED TO PCRJ FOR AGGRAVATED ROBBERY, THEFT OF PROPERTY, AND POSSESSION OF SCHEDULE 1 OR 2 (FENTANYL). APPROXIMATELY \$347.02 IN CASH AND THE SEIZED NARCOTICS WERE LATED STORED AT THE SOUTHWEST SUBSTATION AS EVIDENCE.
