NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL CALL FOR SERVICE. OFFICERS MADE CONTACT WITH MR. PROSSER WHO STATED HE WAS ROBBED FOR \$60 AT GUNPOINT. MR. PROSSER ADVISED HE KNEW THE SUBJECT BUT NOT BY HIS LEGAL NAME. HE STATED HE WAS GIVEN A RIDE BY THE SUSPECT SO HE COULD DONATE PLASMA AND WAS SUPPOSED TO BE GIVEN A RIDE BACK TO HIS RESIDENCE IN NORTH LITTLE ROCK. MR. PROSSER STATED THE SUSPECT KEPT STALLING AND WOULD NOT TELL HIM WHY HE WASN'T TAKING HIM HOME. MR. PROSSER ADVISED THEY PULLED INTO THE DOMINO'S PARKING LOT ON STAGECOACH WHEN HE PULLED A BLACK GLOCK 9MM OUT AND DEMANDED MONEY. MR. PROSSER STATED HE GAVE HIM THE ONLY CASH HE HAD AND GOT OUT OF THE VEHICLE. HE STATED HE GOT A PARTIAL LICENSE PLATE AND OFFICERS WERE ABLE TO FIND THE SUSPECT VEHICLE ON THE FLOCK SAFETY CAMERA SYSTEM. OFFICERS GOT THE LISTED OWNERS INFORMATION AND MADE CONTACT WITH THE SUSPECTS FATHER, MR. DEWAINE DUNCAN AT HIS LISTED ADDRESS. HE STATED HIS SON, HUNTER WAS DRIVING HIS VEHICLE AND WOULD BE AT THIS GIRLFRIENDS HOUSE ON WARWICK DRIVE. OFFICERS RESPONDED TO WARWICK DRIVE WHERE THE SUSPECT VEHICLE WAS FOUND AND OFFICERS COULD ALSO SEE A BLACK GLOCK HANDGUN IN PLAIN VIEW THROUGH THE DRIVERS FRONT WINDOW.
