UPON ARRIVAL, A LOOMIS ARMORED TRUCK WAS PARKED NEXT TO AN ATM AND CONTACT WAS MADE WITH AN EMPLOYEE OF LOOMIS NAMED JOHN MARTIN. MR. MARTIN STATED HE WAS NOT SHOT BUT HAD BEEN SPRAYED WITH MACE.

MR. MARTIN STATED WHILE HE WAS SERVICING THE ATM AN UNKNOWN WHITE MALE APPROACHED HIM AND ASKED, "HOW HE WAS DOING." MR. MARTIN STATED THE WHITE MALE SUBJECT IMMEDIATELY SPRAYED HIM WITH MACE SEVERAL TIMES SO HE PULLED HIS SERVICE WEAPON AND FIRED A COUPLE SHOTS AT THE SUBJECT. MR. MARTIN STATED THE SUBJECT WENT TO THE GROUND AND WAS YELLING BUT WITHIN A FEW SECONDS THE SUSPECT HOPPED ONTO HIS BICYCLE AND FLED WEST TOWARD THE WOODS. MEMS RESPONDED AND TREATED MR. MARTIN ON SCENE.

OFFICERS SECURED THE SCENE WITH CRIME SCENE TAPE AND MAJOR CRIMES DETECTIVES WERE NOTIFIED. WITNESSES WERE LOCATED AND INTERVIEWED BY DETECTIVES.

COMMUNICATIONS LATER ADVISED THAT A GAME AND FISH OFFICER AND ASP WAS OUT WITH THE POSSIBLE SUSPECT ON I-430 NEAR RODNEY PARHAM. THE SUSPECT ADVISED HE WAS SHOT ON GEYER SPRINGS. MEMS RESPONDED AND TRANSPORTED TO AREA HOSPITAL. THE SUSPECT WAS IDENTIFIED AS CHAD GREEN. VEH-2 WAS TOWED TO THE CRIMES SCENE BAY FOR PROCESSING.

THIS INCIDENT IS STILL UNDER INVESTIGATION.

NARRATIVE

ON APRIL 24, 2024, I, OFFICER RICHARDSON RESPONDED TO 9601 BAPTIST HEALTH DRIVE IN REFERENCE TO A SHOOTING VICTIM. UPON ARRIVAL, OFFICERS MADE CONTACT WITH HOSPITAL STAFF.

OFFICERS WERE INFORMED BY HOSPITAL STAFF THAT LEE'S WOUND WAS NOT CRITICAL, AND OFFICERS COULD SPEAK TO HIM. OFFICERS MADE CONTACT WITH LEE IN ER ROOM 2. LEE STATED HE WAS WALKING AT THE PARK LOCATED AT 11106 BIRCHWOOD DRIVE WITH HIS TWO CHILDREN. LEE STATED HE HAD HEARD A SINGLE SHOT COMING FROM AN UNKNOWN LOCATION AND HE "HIT THE GROUND". LEE LATER ADVISED MAJOR CRIME DETECTIVES HE SAW A GROUP OF MALES PLAYING WITH FIREARMS IN THE PAST NEAR THE HALFWAY HOUSE ON WEST MARKHAM. LEE STATED HE WAS UNAWARE HE WAS SHOT INITIALLY AND WENT TO MEET HIS WIFE AT HIS TRUCK. LEE STATED HE BEGAN TO FEEL A STINGING SENSATION IN HIS CHEST. HE REALIZED HE HAD BEEN SHOT ON THE LEFT SIDE OF HIS CHEST. HOSPITAL STAFF WERE ABLE TO DETERMINE THAT HE STILL HAD THE BULLET IN THE RIGHT SIDE OF HIS CHEST, MISSING VITAL ORGANS.

2X70 WAS DISPATCHED TO THE AREA OF BIRCHWOOD PARK IN AN ATTEMPT TO LOCATE A CRIME SCENE WITH NEGATIVE RESULTS.

OFFICERS MADE CONTACT WITH ALLEN. ALLEN STATED SHE DID NOT HEAR ANY SHOTS BEING FIRED. ALLEN STATED LEE STARTED TO COMPLAIN OF A STINGING PAIN IN HIS CHEST AND BROUGHT HIM TO BAPTIST IN THEIR PERSONAL VEHICLE (BLACK 2017 CHEVROLET SILVERADO).

JUVENILE 1 AND JUVENILE 2 STATED THEY DID NOT HEAR ANY SHOTS.

OFFICERS CONTACTED SERGEANT WATSON AND MAJOR CRIMES TO UPDATE THEM ON THE INCIDENT. MAJOR CRIMES DETECTIVES ARRIVED ON SCENE AND TOOK OVER THE INVESTIGATION. MAJOR CRIMES DETECTIVES STATED THAT THE 2017 CHEVROLET TRUCK COULD BE RELEASED TO THE FAMILY.
