## BACKGROUND

The City of Little Rock receives an annual allocation of *HOME Investment Partnerships Program* funds from the U.S. Department of Housing and Urban Development (HUD) to acquire, develop, and/or rehabilitate housing for low to moderate income persons.

An Invitation To Bid (ITB) was completed by the city's Procurement Division for bid events 2570, 2539, 2540. Staff selected the lowest responsive bidders.

- 1.) 4418 Holt was awarded to AJS Homes, LLC, which was the lowest responsive bidder at \$200,500.
- 2.) 4422 Holt was awarded to Renaissance Construction, LLC, which was lowest responsive bidder at \$209,909.57.
- 3.) 4411 Bowers was also awarded to AJS Homes, LLC, was the lowest responsive bidder at \$212,000.

All three (3) properties are located in Ward 6 and the property details are as follows:

Bid No. 2570 for New Home Construction on 4418 Holt Street received three (3) responses, and AJS Homes, LLC, was the low bidder.

Bid No. 2539 for New Home Construction on 4422 Holt Street received four (4) responses, and Renaissance, LLC, was the low bidder.

Bid No. 2540 for New Home Construction on 4411 Bowers Street received five (5) responses, and AJS Homes, LLC, was the low bidder.
