A review committee consisting of citizens and representatives of local community-based organizations met to evaluate the qualifications and responses of the various non-profit organizations of which the above applicants met the minimum qualifications for funding consideration. The Commission on Children, Youth & Families then met and voted to endorse these organizations for a contract award to provide After-School/Out-of-School Time Youth Intervention Programs.
