12	Section 1. That the zoning classification of the following described property be changed from R-4.		
13	Two Family Residential District, to PD-R, Planned District – Residential:		
14	<b>Z-10130</b> : Described as THE South 2/3 of Lots 7-9, Duvall's Subdivision to the City of		
15	Little Rock, Pulaski County, Arkansas.		
16	Section 2. That the preliminary site development plan/plat be approved as presented to the Little Rock		
17	Planning Commission.		
18	<b>Section 3.</b> That the change in zoning classification contemplated for Orndorff #5 – PD-R, located at		
19	2117/2121 Rock Street (Z-10130) is conditioned upon obtaining final plan approval within the time		
20	specified by Chapter 36, Article VII, Section 36-454 (e) of the Code of Ordinances.		
21	<b>Section 4.</b> That this ordinance shall not take effect and be in full force until the final plan approval.		
22	<b>Section 5.</b> That the map referred to in Chapter 36 of the Code of Ordinances of the City of Little Rock,		
23	Arkansas, and the Designated District Map be, and is hereby amended, to the extent and in the respects		
24	necessary to affect and designate the change provided for in Section 1 hereof.		
25	<b>Section 6.</b> Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or		
26	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or		
27			
28	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the		
29	ordinance.		
30	<b>Section 7.</b> <i>Repealer.</i> All laws, ordinances, resolutions, or parts of the same that are inconsistent with
