<b>SYNOPSIS</b>	The applicant is requesting that the 0.11-acre property, located at 413 East 15 <sup>th</sup> Street, be rezoned from C-3, General Commercial District, to PD-C, Planned Development – Commercial, to allow for one (1)-unit (Unit D) of a four (4)-unit apartment building to be used as a Short-Term Rental-2.
<b>FISCAL IMPACT</b>	None.
<b>RECOMMENDATION</b>	Staff recommends approval of the PD-C rezoning request. The Planning Commission voted to recommend approval by a vote of 11 ayes, 0 nays and 0 absent.
<b>BACKGROUND</b>	<p>The applicant proposes to rezone the 0.11-acre property, located at 413 East 15<sup>th</sup> Street, from C-3, General Commercial District, to PD-C, Planned Development – Commercial, to allow for the use of the property as a Short-Term Rental-2, with a maximum stay of twenty-nine (29) days. The owner will not reside in the residence, which is an existing four (4)-unit apartment building.</p> <p>The property is a 2,769 square-foot, two (2)-story, four (4)-unit apartment building. The request is for Unit D, which is a one (1)-bedroom, one (1)-bath second-floor unit. The unit has one (1) dedicated on-street parking front of the building.</p>

**BACKGROUND  
CONTINUED**

The property is located within the Downtown, MacArthur Park and the Pettaway Neighborhood Organizations, as well as the Central City Design Overlay District. The Future Land Use Plan shows Residential Medium Density (RM) for the requested area.

On June 20, 2023, the Board of Directors passed Ordinance No. 22,274, which regulates Short-Term Rentals within the City of Little Rock. The new ordinance establishes “development standards” for Short-Term Rentals. If approved, the applicant must comply with the newly established development standards as follows, in addition to all other requirements of the new ordinance.

All trash pick-up shall comply with requirements for residential one (1)–and two (2)-family residential zones.

Currently the City of Little Rock Department of Planning and Development has sixty-eight (68) Short-Term Rentals (STR-1 and STR-2) listed within the database for approved Short-Term Rentals in the City of Little Rock. The City’s new Short-Term Rental Ordinance allows a maximum 500 Short-Term Rentals within the corporate boundary of the City of Little Rock.

The applicant provided responses and additional information to all issues raised during staff’s review of the application. The applicant is requesting no variances with the PD-C zoning request.

The Planning Commission reviewed this request at their January 11, 2024, meeting, and there were no objectors present. All owners of property located within 300 feet of the site, as well all Neighborhood Associations registered within the City of Little Rock, were notified.
