**A RESOLUTION TO AUTHORIZE THE CITY MANGER TO ENTER INTO A CONTRACT WITH POSITIVE RESULTS LAWN SERVICES, INC., IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FORTY-SIX THOUSAND, SIX HUNDRED FORTY DOLLARS (\$146,640.00), FOR THE PLEASANT TREE DRIVE DRAINAGE IMPROVEMENT PROJECT; AND FOR OTHER PURPOSES.**

**WHEREAS,** bids were solicited for the Pleasant Tree Drive Drainage Improvement Project, Bid No. 2152; and,

**WHEREAS,** it was determined that Positive Results Lawn Services, Inc., was the lowest responsive, responsible bid meeting specifications out of six (6) bids received for the project.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF LITTLE ROCK, ARKANSAS:**

**Section 1.** The City Manager is hereby authorized to execute an agreement with Positive Results Lawn Services, Inc., for the Pleasant Tree Drive Drainage Improvement Project, in an amount not to exceed One Hundred Forty-Six Thousand, Six Hundred Forty Dollars (\$146,640.00), which is the base bid amount of One Hundred Twenty-Two Thousand, Two Hundred Dollars (\$122,200.00), plus 20% contingencies.

**Section 2.** Funding for this project is from the ⅜-Cent Capital Improvement Sales and Compensating Use Tax Funds and the Limited Tax General Obligation Capital Improvement Bonds as authorized by Resolution No. 14,803.

**Section 3. Severability.** In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the resolution.

**Section 4. Repealer.** All laws, ordinances, resolutions, or parts of the same, that are inconsistent with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
