3 **A RESOLUTION TO APPROVE THE AMENDED SOURCES AND USES**
4 **OF FUNDS PROVIDED IN THE 2017 CDBG, HOME, AND HOPWA**
5 **FUNDS FROM THE U.S. GOVERNMENT; AND FOR OTHER PURPOSES.**

7 **WHEREAS**, the City set forth its list of priorities for the use of 2017 CDBG, HOME and HOPWA
8 Funds in Little Rock, Ark., Resolution No. 14,420 (September 20, 2016); and,

9 **WHEREAS**, the total requested amount of funding was Two Million, Three Hundred Fifty-Nine
10 Thousand, Nine Hundred Nineteen Dollars (\$2,359,919.00), and the total funding grant was Two Million,
11 One Hundred Twelve Thousand, Seven Hundred Thirty-Nine Dollars (\$2,112,739.00), but projected project
12 income increases that amount to Two Million, Three Hundred Twelve Thousand, Seven Hundred Thirty-
13 Nine Dollars (\$2,312,739.00); and,

14 **WHEREAS**, it is necessary for the City to amend the sources and use of funds from these Federal
15 programs;

16 **NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY**
17 **OF LITTLE ROCK, ARKANSAS:**
