## **NARRATIVE**

OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE VALERO GAS STATION, LOCATED AT 6500 MABELVALE CUTOFF. UPON OFFICERS ARRIVAL, CONTACT WAS MADE WITH TWO B/M'S INSIDE THE GAS STATION, BOTH SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS AND FIRE RESCUE RESPONDED TO THE SCENE. MEMS PRONOUNCED ONE OF THE VICTIMS DECEASE ON SCENE. THE OTHER VICTIM, LATER IDENTIFIED AS ALEXIS OLIVER WAS TRANSPORTED TO UAMS, LISTED IN CRITICAL CONDITION. HOMICIDE DETECTIVES RESPONDED TO THE SCENE AND OBSERVED BOTH VICTIMS BEING TREATED BY MEMS. DETECTIVES WERE ABLE TO OBTAIN VIDEO SURVEILLANCE. DETECTIVES MADE A BROADCAST FOR SUSPECT AND SUSPECT VEHICLE. CRIME SCENE PERSONNEL WAS CONTACTED, RESPONDED AND PROCESSED THE SCENE. SUSPECT, LATER IDENTIFIED AS DAVIS LAMONT JONES (B/M 02/10/1991) WAS TAKEN IN CUSTODY BY ARKANSAS STATE POLICE. MR. JONES WAS TRANSPORTED TO THE MAJOR CRIMES DIVISION. THE SUSPECT VEHICLE, MERCEDES-BENZ WAS TOWED TO THE CRIME SCENE BAY.

THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO THE SCENE AND RETRIEVED THE UNIDENTIFIED VICTIM WHO WILL BE TRANSPORTED TO THE CRIME LAB FOR AN AUTOPSY AND POSITIVE IDENTIFICATION. DETECTIVES RESPONDED TO MAJOR CRIMES DIVISION AND INTERVIEWED WITNESSES. MR. JONES WAS COMPLAINING OF PAIN, SO MEMS RESPONDED TO CHECK MR. JONES. MR. JONES BECAME COMBATIVE AND STRUCK ONE OF THE MEMS PERSONNEL. DUE TO MR. JONES BEING COMBATIVE, NO STATEMENT WAS OBTAINED AT THIS TIME. MR. JONES WAS CHARGED WITH CAPITAL MURDER, CRIMINAL ATTEMPT - CAPITAL MURDER, POSSESSION OF FIREARM BY CERTAIN PERSONS AND BATTERY 2ND. MR. JONES WAS TRANSPORTED TO PCRJ.

NEXT OF KIN IS PENDING UNTIL POSITIVE IDENTIFICATION OF DECEASED VICTIM.
