UPON ARRIVAL, OFFICERS LOCATED THE VICTIM, MR. ERNESTO OLMOS SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS PERSONNEL WERE NOTIFIED AND RESPONDED TO THE SCENE. MR. OLMOS WAS TRANSPORTED TO UAMS AND ULTIMATELY SUCCUMBED TO HIS INJURIES. OFFICERS ESTABLISHED A CRIME SCENE. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE NOTIFIED AND RESPONDED TO THE SCENE. HOMICIDE DETECTIVES CANVASSED THE AREA FOR SURVEILLANCE. DETECTIVES NOTIFIED MR. OLMOS WIFE, MS. TIFFANY OLMOS, OF THE INCIDENT.
