NARRATIVE

ON SATURDAY, SEPTEMBER 17TH, 2022, AT APPROXIMATELY 0413 HOURS, NORTHWEST PATROL OFFICERS RESPONDED TO 9501 BAPTIST HEALTH DRIVE IN REFERENCE TO A SHOOTING REPORT CALL FOR SERVICE. THE CALLER ADVISED A GUNSHOT WOUND VICTIM ARRIVED AT THE BAPTIST HEALTH EMERGENCY DEPARTMENT, THE OPERATOR OF THE VEHICLE LEFT THE LOCATION.

UPON ARRIVAL, OFFICERS LEARNED THAT THE VICTIM, RANDY TURNER, SUCCUMBED TO HIS INJURIES AT BAPTIST HOSPITAL. AT APPROXIMATELY, 0531 HOURS, A SECOND CALLER, ADVISED THEY OBSERVED BLOOD AT THE TACO BELL, LOCATED AT 1300 JOHN BARROW ROAD. OFFICERS RESPONDED TO THE LOCATION; A CRIME SCENE WAS LOCATED INSIDE OF THE BUSINESS. THE CRIME SCENE WAS SECURED. HOMICIDE DETECTIVES AND CSSU PERSONNEL WAS NOTIFIED TO RESPOND TO THE LOCATION.

HOMICIDE DETECTIVES RESPONDED TO THE CRIME SCENE AND BEGAN THE PRELIMINARY. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND VIDEO SURVEILLANCE CAMERAS. DETECTIVES OBTAINED RECORDED STATEMENTS FROM WITNESSES.

THE PULASKI COUNTY CORONERS OFFICE WAS NOTIFIED TO RESPOND TO BAPTIST HOSPITAL. MR. TURNER WAS TRANSPORTED TO THE ARKANSAS STATE CRIME LABORATORY FOR AN AUTOPSY.
