NARRATIVE

ON TODAYS DATE AT APPROXIMATELY 0000 HOURS LRFD E11 LOCATED A POSSIBLE VICTIM OF A PEDESTRIAN ACCIDENT IN FRONT OF 5502 WEST 65TH STREET. MEMS WAS REQUESTED. DISPATCH RECEIVED A CALL FROM A PERSON REPORTING SEVERAL SHOTS HEARD IN THE AREA AND THEY SAW A BLACK MALE LYING IN THE MIDDLE OF THE STREET. OFFICERS ARRIVED ON SCENE AND OBSERVED SHELL CASINGS IN THE STREET NEAR THE VICTIM. THE VICTIM WAS TRANSPORTED TO UAMS WHERE HE WAS PRONOUNCED DECEASED. CSSU AND HOMICIDE DETECTIVES WERE CALLED AND RESPONDED TO THE SCENE. DETECTIVES CANVASSED THE AREA AND ATTEMPTED TO LOCATE WITNESSES.

THE CORONER RESPONDED TO UAMS AND TOOK CUSTODY OF THE VICTIM AND TRANSPORTED HIM TO THE MEDICAL EXAMINERS OFFICE FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THIS INVESTIGATION IS ONGOING.
