NARRATIVE

ON MONDAY, MARCH 27, 2023, AT APPROXIMATELY 1600 HOURS, OFFICERS RESPONDED TO 4704 FAIRLEE DRIVE FOR A "SHOOTING JUST OCCURRED" CALL FOR SERVICE. OFFICERS ARRIVED AND LOCATED MS. EDWIN BROWN INSIDE THE RESIDENCE SUFFERING FROM APPARENT GUNSHOT WOUNDS. MS. BROWN WAS TRANSPORTED BY MEMS TO UAMS WHERE SHE WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED TO BEGIN A PRELIMINARY INVESTIGATION. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE. MS. BROWN'S BODY WAS TRANSPORTED TO THE ARKANSAS STATE CRIME LAB BY THE PULASKI COUNTY CORONER'S OFFICE FOR AN AUTOPSY. THIS INVESTIGATION IS ON-GOING.
