OFFICERS RESPONDED TO CHILDREN'S HOSPITAL IN REFERENCE TO A 2 MONTH OLD CHILD ARRIVING WITH SEVERE INJURIES. OFFICERS MADE CONTACT WITH SUSP #1 (MR. PENNINGTON), THE JUVENILE VICTIM'S FATHER, AND MS. SMITH, THE JUVENILE VICTIM'S MOTHER. OFFICERS WERE ADVISED THE VICTIM WAS IN CRITICAL CONDITION AND WAS SUFFERING FROM SEVERE INTERNAL AND EXTERNAL INJURIES. OFFICERS TRANSPORTED MR. PENNINGTON AND MS. SMITH TO THE 12TH STREET STATION TO BE INTERVIEWED BY DETECTIVES. FOLLOWING HER INTERVIEW, MS. SMITH WAS RELEASED WITHOUT CHARGES. MR. PENNINGTON WAS SUBSEQUENTLY CHARGED WITH BATTERY IN THE FIRST DEGREE. MR. PENNINGTON WAS TRANSPORTED TO PCRJ WITHOUT INCIDENT.
