## **NARRATIVE**

OFFICERS WERE DISPATCHED TO A DISTURBANCE WITH A WEAPON CALL FOR SERVICE IN THE AREA OF ROOSEVELT AND MAIN. A REFUSED CALLER ADVISED OF A WHITE CAR SHOOTING AT A GRAY VEHICLE. SHORTLY AFTER, OFFICERS WERE ADVISED A GRAY VEHICLE HAD ARRIVED AT UAMS WITH A SUBJECT SUFFERING FROM APPARENT GUNSHOT WOUNDS. LIFE SAVING MEDICAL TREATMENT WAS PERFORMED BUT THE MALE, MARVELL HARRIS SUCCUMBED TO HIS INJURIES. OFFICERS WERE ADVISED THE INCIDENT OCCURRED AROUND ROOSEVELT AND BROADWAY. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE NOTIFIED AND RESPONDED. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED TO UAMS AND THE BODY OF MR. HARRIS WAS TRANSPORTED TO THE ARKANSAS STATE CRIME LAB PENDING AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THIS INVESTIGATION IS ONGOING.
