NARRATIVE

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A BATTERY JUST OCCURRED. UPON ARRIVAL, OFFICERS MADE CONTACT WITH TARGET MANAGER RYAN MESSERSMITH, WHO ADVISED HE WAS ASSAULTED BY AN UNKNOWN BLACK MALE ATTEMPTING TO EXIT THE STORE WITH MERCHANDISE HE DID NOT PAY FOR.

MR. MESSERSMITH ADVISED HE HAD BEEN OBSERVING THE MALE SELECTING MERCHANDISE IN THE STORE AND PUTTING CLOTHING ITEMS ON HIS PERSON. MR. MESSERSMITH ADVISED THE MALE PROCEEDED TO SELECT MORE CLOTHING, PLACED IT IN A SHOPPING CART, THEN EXIT THE STORE. MANAGEMENT WAS UNSURE OF THE TOTAL COSTS OF THE STOLEN MERCHANDISE AT THE TIME OF THIS REPORT. OFFICERS LISTED AN ESTIMATE PENDING INVENTORY.

MR. MESSERSMITH ADVISED HE ATTEMPTED TO STOP THE MALE WHILE EXITING THE STORE. MANAGEMENT ADVISED HE GRABBED THE BASKET THE CLOTHING ITEMS WERE IN, IN AN ATTEMPT TO SECURE THE MERCHANDISE. MR. MESSERSMITH ADVISED HE BEGAN PUSHING THE BASKET BACK IN THE STORE, BUT WAS SHOVED FROM BEHIND BY THE MALE, AND FELL DOWN. OFFICERS OBSERVED VIDEO FOOTAGE OF THIS INCIDENT ON STORE SECURITY CAMERAS.

MR. MESSERSMITH DECLINED MEDICAL ATTENTION. OFFICERS PROVIDED MANAGEMENT WITH AN INCIDENT NUMBER. NO FURTHER ACTION WAS TAKEN. MVR AND BWC IN USE.
