NARRATIVE

OFFICERS RESPONDED TO A CRIMINAL MISCHIEF CALL. UPON ARRIVAL OFFICERS MADE CONTACT WITH THE JORGE GONZALEZ. GONZALEZ STATED HE AND JUVENILE 1 (FRONT PASSENGER) WERE ON THE WAY HOME FROM THE GYM WHEN HIS VEHICLE WAS SHOT NEAR 1020 S. UNIVERSITY. MR. GONZALEZ STATED VEHICLE 2 WAS SWERVING IN AND OUT OF TRAFFIC IN A FIT OF RAGE. MR. GONZALES STATED A BLACK MALE PULLED TO THE PASSENGER SIDE OF HIS VEHICLE, POINTED A PINK RIFLE AT HIM, AND SHOT HIS PASSENGER DOOR ONE TIME. VEHICLE 2 PROCEEDED WESTBOUND ON 12TH ST. FROM UNIVERSITY. MR. GONZALEZ WENT HOME TO CONTACT POLICE.

MR. GONZALEZ STATED THE DRIVER WAS A LIGHT-SKIN BLACK MALE, WITH AN AFRO, APPROXIMATELY 5'4, 19-20 YEARS OLD. MR. GONZALEZ STATED THE VEHICLE WAS A BLACK HONDA ACCORD, WITH DARK TINT, AND STOCK WHEELS.

VEHICLE 1 HAD A BULLET HOLE IN THE PASSENGER DOOR THAT PROCEED TO GO THROUGH THE GLOVE BOX. OFFICERS OBSERVED BULLET FRAGMENTS IN THE GLOVE BOX.

SERGEANT TINER WAS NOTIFIED. OFFICERS PROCEEDED TO MAKE A BROADCAST TO ALL UNITS. OFFICERS CANVASED THE AREA WITH NEGATIVE RESULTS. DETECTIVE HARRIS WAS NOTIFIED AND RESPONDED TO THE CALL.

BASED ON THE DESCRIPTION PROVIDED, OFFICERS DEVELOPED MR. VALUE JR. AS A SUSPECT. VEHICLE 2 MATCHED THE DESCRIPTION PROVIDED.
