NARRATIVE

OFFICERS WERE DISPATCHED TO A BATTERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE LIQUOR SIDE MANAGER OF THE COSTCO, ADRIANNE SCHIMMELPFENNIG. MS. ADRIANNE STATED THAT 3 UNKNOWN BLACK FEMALES HAD ENTERED THE STORE. SHE FURTHER STATED THAT THE YOUNGEST OF THE FEMALES HAD PICKED UP SOME LIQUOR. MS. ADRIANNE STATED SHE TOLD THE YOUNGEST FEMALE THAT SHE COULD NOT HOLD THE LIQUOR DUE TO STATE LAW. THE FEMALE BECAME VIOLENT TOWARDS HER AND SHOVED HER INTO A BRICK WALL WHILE YELLING "DONT TOUCH ME". MS. ADRIANNE STATED THAT SHE THEN FOLLOWED THE 3 FEMALES OUTSIDE AT WHICH TIME SHE WAS ABLE TO RETRIEVE A BOTTLE OF CROWN ROYAL FROM ONE. AT THIS POINT ONE OF THE SUSPECTS STRUCK MS. ADRIANNE IN THE FACE WITH A CLOSED FIST CAUSING MINOR REDNESS AND SWELLING TO THE LEFT SIDE OF HER FACE. THE SUSPECTS THEN FLED IN A RED DODGE CHARGER LPN LODCSO. NARRATIVE

AT APPROXIMATELY 2018 HOURS I WAS DISPATCHED TO 10422 CHICOT ROAD FOR A THEFT JUST OCCURRED. UPON ARRIVAL I MADE CONTACT WITH MR. REDDY WHO WAS WALKING MR. CLARK OUT OF THE STORE. MR. CLARK TO THE FRONT OF MY PATROL VEHICLE AND SEARCHED MR. CLARK INCIDENT TO ARREST WITH NEGATIVE RESULTS. I THEN SECURED MR. CLARK IN THE BACKSEAT OF MY PATROL VEHICLE AND SECURED THE SEATBELT.

AT THIS TIME, I WALKED INTO THE STORE, EXXON, AND MADE CONTACT WITH MR. REDDY ONCE AGAIN. MR. REDDY ADVISED ME THAT MR. CLARK CAME INTO THE STORE, SNATCHED TWO VAPES OFF OF THE COUNTER AND THEN RAN OUT OF THE STORE. MR. REDDY STATED HE CHASED AFTER MR. CLARK TO GET THE ITEMS BACK. MR. REDDY STATED THEY RAN ACROSS MABELVALE CUTOFF TO A FIELD WHERE HE GRABBED MR. CLARK LEGS TO GET HIM TO STOP. MR. REDDY ADVISED THAT MR. CLARK THEN STRUCK HIM IN THE HEAD MULTIPLE TIMES. MR.
