NARRATIVE

ON 06/18/2024, AT APPROXIMATELY 1631 HOURS, OFFICERS RESPONDED TO A SHOOTING CALL AT AVONDALE APARTMENTS LOCATED AT 1812 RESERVOIR RD. COMMUNICATIONS ADVISED ONE SUBJECT WAS SHOT NEAR **BUILDING 24.**

UPON ARRIVAL, OFFICERS WERE STOPPED BY RESIDENTS COMING OUT OF BUILDING 22A. OFFICERS OBSERVED MULTIPLE SHELL CASINGS ON THE GROUND IN FRONT OF THE BUILDING. THE LISTED VEHICLES HONDA(ALP18S) AND MALIBU (247TSS) WERE PARKED IN FRONT OF THE BUILDING AND THEY APPEARED TO HAVE BEEN STRUCK BY BULLETS. OFFICERS OBSERVED A HANDGUN IN THE BREEZEWAY ON THE FIRST FLOOR IN THE MIDDLE PORTION OF THE BUILDING. IT WAS A TAN/GREEN GLOCK 19X (SERIAL NUMBER). THE SLIDE OF THE HANDGUN WAS NOT IN LINE WITH THE BARRIER BUT IT WAS ALSO NOT LOCKED TO THE BACK.

OFFICERS WERE THEN NOTIFIED THAT THERE WAS A PERSON SHOT IN APARTMENT 284. I WAS THE ONLY PERSON ON SCENE, SO I TOOK THE GUN WITH ME SO THAT I COULD SECURE THE VICTIM THAT WAS SHOT. MULTIPLE OFFICERS ARRIVED ON SCENE SHORTLY AFTER AND A CRIME SCENE WAS SET UP. THE PERSON SHOT WAS DARQUAHN DOOLITTLE. HE WAS IN THE DOOR WAY OF APT 284 AND HE APPEARED TO HAVE GUN SHOT WOUNDS TO HIS LEGS. IT APPEARED THAT THE BLEEDING WAS CONTROLLED.

OFFICERS CLEARED APT 284 FOR PEOPLE AND THEN STARTED OBTAINING INFORMATION REGARDING TO THE SHOOTING. WHILE THIS WAS TAKING PLACE, OFFICERS RECEIVED INFORMATION THAT THE SUSPECTS FLED THE SCENE IN A WHITE JEEP CHEROKEE WITH DEALER TAG EX60857. THE VEHICLE WAS LATER LOCATED NEAR LABETTE MANOR AND JOHN BARROW. OFFICERS INITIATED A TRAFFIC STOP ON THE SUSPECT VEHICLE AND THREE SUBJECTS RAN ON FOOT. TWO SUSPECTS WERE TAKEN INTO CUSTODY. ONE SUSPECT WAS TORRIO BAKER AND THE OTHER ONE WAS J1. OFFICERS RECOVERED A GLOCK 23 WITH SERIAL NUMBER J1'S BACKPACK THAT HE WAS WEARING WHILE RUNNING AWAY FROM THE POLICE. THE PISTOL SHOWED TO BE STOLEN OUT OF NORTH LITTLE ROCK (2024-13294).

THE SUSPECT VEHICLE WAS TOWED TO THE CRIME SCENE BAY.

DOOLITTLE WAS TRANSPORTED TO BAPTIST. DOOLITTLE'S SISTER, TONYAE JONES, WAS IN THE APARTMENT WITH HIM AT THE TIME OF THE INCIDENT. JONES ADVISED HER BROTHER WENT OUTSIDE AND SHE HEARD VERBAL ALTERCATION. SHE ADVISED SHORTLY AFTER SHE STARTED HEARING GUN SHOTS AND HER BROTHER WAS STRUCK, THERE WERE BULLET HOLES OUTSIDE OF THEIR APARTMENT.

EZRA PATTERSON IN APT 282 (EAST OF APT 284) WAS HOME AT THE TIME OF THE INCIDENT. HE DID NOT OBSERVE ANYTHING BUT HIS VEHICLE (ALP18S) WAS STRUCK.

KATHERINE WHALEY IN APT 281 (NORTH EAST OF APT 284) WAS HOME AT THE TIME OF THE INCIDENT. SHE DID NOT OBSERVE ANYTHING BUT HER VEHICLE (247TSS) WAS STRUCK.

LACY HARTWELL IN APT 283 (NORTH OF 284) WAS NOT HOME AT THE TIME OF THE INCIDENT AND THE LANTERN OUTSIDE HER DOOR WAS SHOT.

MYA FOWLER IN APT 181 (NORTH EAST AND DOWNSTAIRS OF 284) WAS HOME AT THE TIME OF THE INCIDENT.

KAMERIEL ROGERS IN APT 183 (NORTH AND DOWNSTAIRS OF 284) WAS HOME AND SHE STATED A BULLET CAME THROUGH THE WINDOW AND STRUCK A WALL. A HOLE IN THE WINDOW WAS OBSERVED.

SHEQUISE BYERS AN HER HUSBAND KANYARDIS FOREMAN IN APT 142 (ACROSS FROM 284) WERE IN VEHICLE (DA631154) AT THE TIME OF THE INCIDENT. THEIR APARTMENT HAD A HOLE IN THE WINDOW. THEY ADVISED THEY SAW PART OF THE INCIDENT.

KRISTAL JOHNSON IN APT 243 (ACROSS FROM 284) WAS HOME AND HER VEHICLE (ONLYME) WAS SHOT.

A BARBARA WILDER ALSO CLAIMED THAT SHE WAS THE OWNER OF VEHICLE (ALP18S). SHE ASKED FOR A SUPERVISOR WHILE OFFICERS WERE SETTING UP THE CRIME SCENE AND SHE WAS SEEN WALKING UP TO THE SHELL CASINGS. SHE WAS UPSET BECAUSE SHE WAS YELLED AT AND SERGEANT TINER WAS ONSCENE AND SHE

WAS SPOKEN WITH.

A WITNESS APPROACHED OFFICERS ON SCENE. LUKE CHILDRESS ADVISED HE WAS PULLING INTO 1812 RESERVOIR AND HE HEARD GUNSHOTS FROM THE AREA. HE ADVISED HE OBSERVED A WHITE JEEP LEAVING THE SCENE AND HE OBSERVED 3 BLACK MALES INSIDE THE VEHICLE. HE ADVISED THERE WAS A DENT IN THE BACK OF THE VEHICLE AND THE LICENSE PLATE WAS A DEALER TAG EX60857.

AT THE TIME OF THE REPORT, DOOLITTLE HAD AT 4 GUNSHOT WOUNDS TO BOTH LEGS BUT HE WAS IN STABLE CONDITION.
