NARRATIVE

OFFICERS RESPONDED TO 700 SOUTH BOWMAN FOR A ROBBERY OF AN INDIVIDUAL CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH VICT#1(MUJAHID).

MS. MUJAHID ADVISED SHE HAD JUST BEEN ROBBED AT GUN POINT BY A GROUP OF INDIVIDUALS. MS. MUJAHID ADVISED A BLACK FEMALE FOLLOWED HER INTO THE PARKING LOT FROM WALMART. WHEN SHE ARRIVED AT HER VEHICLE(VEH#1), THE BLACK FEMALE BEGAN TALKING TO HER AND FIGHTING HER NEXT TO HER VEHICLE. DURING THE FIGHT, TWO BLACK MALES APPROACHED HER VEHICLE AND BEGAN STEALING THE LISTED PROPERTY. MS. MUJAHID ADVISED SHE BEGAN WINNING THE FIGHT AGAINST THE BLACK FEMALE, THEN BOTH BLACK MALES WALKED OVER AND HIT HER WITH A HANDGUN ON HER HEAD. THE BLACK FEMALE STARTED STEALING FROM THE VEHICLE. THE THREE INDIVIDUALS THEN TOOK HER THINGS TO THEIR VEHICLE (VEH#2). MS. MUJAHID ADVISED SHE FOLLOWED THEM TO THE VEHICLE AND WAS VERBALLY ARGUING WITH ONE BLACK MALE. DURING THIS ARGUMENT ONE BLACK MALE (ELIJAH SCRUGGS) POINTED THE GUN TOWARD HER, TELLING HER TO GET OUT OF THE WAY. VEH#2 THEN BACKED OUT OF THE SPOT NARROWLY MISSING MS. MUJAHID. MS. MUJAHID ADVISED THAT SHE LAST SAW THE VEHICLE HEADING SOUTH THROUGH THE WALMART PARKING LOT.

MS. MUJAHID ADVISED SHE DID NOT NEED MEDICAL ATTENTION ON SCENE. MS. MUJAHID WAS GIVEN THE INCIDENT NUMBER RELATED TO THE CALL. OFFICERS MADE CONTACT WITH WALMART ASSET PROTECTION WHO WERE ABLE TO PULL UP CAMERA FOOTAGE OF THE INCIDENT. OFFICERS WERE ABLE TO MAKE OUT THE LICENSE PLATE ON VEH#2. OFFICERS PERFORMED A BROADCAST OVER THE RADIO WITH INFORMATION THEY HAD AT THE TIME. MS. MUJAHID ADVISED SHE KNEW ONE OF THE MEN AS ELIJAH SCRUGGS. MS. MUJAHID ADVISED SHE HAD A PREVIOUS BUSINESS DEALING WITH MR. SCRUGGS. MS. MUJAHID ADVISED THAT MR. SCRUGGS REFERRED TO THE FEMALE AS ASHLEY. MS. MUJAHID ADVISED ELIJAH HAS A BLACK GLOCK WITH A SWITCH AND SUSPECT 2 HAD A BROWN GLOCK WITH A SWITCH AND LASER.

SHORTLY AFTER, OFFICERS MADE CONTACT WITH MS. MUJAHID VIA PHONE AND SHE ADVISED HER PHONE WAS PINGING AT 4216 S. BOWMAN (ARLO APARTMENTS). OFFICERS RESPONDED TO THE SCENE, HOWEVER THE VEHICLE OR SUSPECTS WERE UNABLE TO BE LOCATED. AS OFFICERS WERE LEAVING THE AREA, MS. CAMPBELL SHOWED UP, WAIVED OFFICERS DOWN, AND ADVISED SHE HAD FOUND HER PHONE ON BOWMAN ROAD BY THE APARTMENT ENTRANCE.
