NARRATIVE

ON 06/26/2024, AT APPROXIMATELY 1550 HOURS, OFFICERS RESPONDED TO AN AGGRAVATED ROBBERY OF BUSINESS AT 3710 S UNIVERSITY THE WALGREENS. AT THE TIME OF DISPATCH, OFFICERS THOUGHT THE ROBBERY HAD JUST OCCURRED, BUT THE CALL TIME WAS ACTUALLY 1504 AND OFFICERS DID NOT RECALL COMMUNICATIONS REQUESTING OFFICERS TO RESPOND.

OFFICERS MADE CONTACT WITH PHARMACIST CHARLES JOHNSON AND TECHNICIAN GABIN WALKER. JOHNSON ADVISED THE SUSPECT WAS A BLACK MALES IN HIS 20S WHO WAS WEARING A RED HAT, BLACK BAG, WHITE SHIRT AND BLACK PANTS. HE ADVISED HE WAS 5'9" TALL AND MAYBE 180 LBS WITH A THICK BEARD. JOHNSON ADVISED THE SUSPECT JUMPED THROUGH THE WINDOW CONNECTING THE STORE AND THE PHARMACY. JOHNSON ADVISED HE OBSERVED THE SUSPECT COLLECTING COUGH SYRUP FROM THE SHELF AND HE CONFRONTED THE SUSPECT. JOHNSON ADVISED THE SUSPECT PUSHED HIM AWAY AND STARTED RUNNING TOWARD THE OTHER EMPLOYEES. JOHNSON ADVISED HE TRIED TO GRAB HIM AND WALKER JOINED TO HELP HIM. JOHNSON ADVISED THE SUSPECT JUMPED THROUGH THE WINDOW AGAIN AND DROPPED A POCKET KNIFE. HE ADVISED THE SUSPECT THEN SAID,"I'M GOING TO SHOOT YOU." HE ADVISED HE THEN BACKED UP AND SAW THE SUSPECT RUNNING OUT OF THE FRONT DOOR. IT WAS UNKNOWN IF THERE WAS A VEHICLE INVOLVED.

WALKER ADVISED HIS RIGHT ARM WAS HURTING AND HE MIGHT HAVE GOTTEN INJURED DURING THE ALTERCATION. HE ADVISED HE HEARD THE SUSPECT MADE THREATS TOWARD JOHNSON AND HE ADVISED THE SUSPECT SAID,"I WILL PUT A GUN ON YOUR HEAD."

THE SUSPECT GOT AWAY WITH 1 BOTTLE OF COUGH SYRUP:

SERGEANT TINER WAS NOTIFIED OF THE INCIDENT. MAJOR CRIMES DETECTIVE WAS ADVISED AND THEY RESPONDED TO THE SCENE TO TAKE STATEMENTS. OFFICERS WERE ADVISED TO COLLECT POSSIBLE FINGERPRINTS AS CRIME SCENE UNIT WAS NOT RESPONDING. VIDEO SURVEILLANCE OF THE INCIDENT WAS AVAILABLE FOR DETECTIVES TO REVIEW.

OFFICERS OBTAINED 4 FINGERPRINT CARDS FROM THE COUGH SYRUP BOTTLES DROPPED BY THE SUSPECT AND STORED THEM AT THE NORTHWEST STATION. OFFICERS ALSO STORED THE RED HAT, THE BLACK BAG AND THE POCKET KNIFE DROPPED BY THE SUSPECT.
