NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED ADDRESS FOR A BATTERY. OFFICERS ARRIVED ON SCENE TO AND MADE CONTACT WITH VICTIM #1, STEPHANIE FOREMAN. FOREMAN STATED ONE OF HER FRIENDS, SUSPECT #1, CHRIS, HAD GRABBED HER BY THE NECK AND TOOK A TEN DOLLAR BILL OUT OF HER PURSE THAT WAS JUST GIVEN TO HER. WHILE GIVING THE PURSE BACK TO HER, FOREMAN STATED HE THREATENED TO "BEAT HER ASS IF SHE CALLED THE COPS". FOREMAN ADVISED SHE COULD BREATHE THE WHOLE TIME AND THAT HE JUST GRABBED HER BY THE THROAT FOR A BRIEF MOMENT. FOREMAN STATED CHRIS THEN GOT INTO A BLACK HONDA UNKNOWN MODEL, UNKNOWN LICENSE PLATE, AND STARTED TO TRAVEL EASTBOUND ON MARKHAM ST.

OFFICERS OBSERVED NO INJURY, PROVIDED AN INCIDENT CARD AND CANVASED THE SURROUNDING AREAS MAKING MULTIPLE STOPS IN ATTEMPT TO FIND THE HONDA OR THE DESCRIPTION OF THE SUSPECT GIVEN WITH NEGATIVE RESULTS.
