NARRATIVE

OFFICERS RESPONDED TO THE LOCATION AND MADE CONTACT WITH JUV #1, AN EMPLOYEE OF THE BUSINESS. JUV #1 STATED HE OBSERVED SUSP #1 (MS. SMITH) AT THE SELF CHECKOUT STATION NOT SCANNING ALL OF HER ITEMS. JUV #1 STATED HE KNEW THIS TO BE FALSE. JUV #1 STATED THE MANAGER, WHO WAS NO LONGER ON SCENE AT THE TIME OF THE REPORT, OF THE BUSINESS THEN CAME OVER TO HIM. JUV #1 STATED THE MANAGER ADVISED MS. SMITH SHE COULD NOT LEAVE WITH THE ITEMS SHE HAD NOT PAID FOR. JUV #1 STATED MS. NARRATIVE

OFFICERS RESPONDED TO KROGER FOR A CUTTING. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH JALEN BURKS, WHO ADVISED HE WAS WORKING ON A REGISTER WHEN HE OBSERVED FOUR INDIVIDUALS TRYING TO EASE THEIR WAY TO THE DOOR WITH UNPAID GROCERIES. BURKS ADVISED HE ASKED THE INDIVIDUALS DID THEY PAY FOR THE GROCERIES AND THEY TOLD HIM YES AND GAVE A RANDOM EMPLOYEE. BURKS ADVISED THE EMPLOYEE TOLD HIM NO THEY DID NOT CHECK THEM OUT AND THE INDIVIDUALS KEPT INCHING TOWARD TO EXIT DOOR WITH THE BASKET OF GROCERIES. BURKS ADVISED ONE OF THE SUSPECTS STARTED TALKING DISRESPECTFUL TO HIM AND HE RESPONDED BACK WITH "YO MAMA", AND THE OTHER SUSPECTS BEGAN TO GET AGGRESSIVE WITH HIM AND ATTEMPTED TO ATTACK HIM. BURKS ADVISED A HEAVY SET BLACK FEMALE OPENED UP LIQUID LAUNDRY DETERGENT AND STARTED THROWING IT ON HIM. BURKS STATED THAT SOME OF THE DETERGENT GOT IN HIS EYES AND MOUTH AND HE COULD NOT SEE CLEARLY BUT COULD SEE THE SUSPECTS APPROACHING HIM. BURKS TOLD OFFICERS HE PULLED OUT A KNIFE AND BELIEVES HE CUT A BLACK FEMALE WEARING AND ORANGE SHIRT AND BLACK BIKER SHORTS WITH A BONNET ON. BEALS BELIEVED HE SWALLOWED DETERGENT, OFFICERS HAD MEMS RESPOND TO THE LOCATION. MEMS UNIT 14 RESPONDED AND CHECKED BURKS FOR HIS INJURIES.

OFFICERS WATCHED THE VIDEO AND OBSERVED A BLACK FEMALE WEARING ORANGE RUNNING AROUND AND KNOCKING OVER THE GIFT CARD STANDS AND DESTROYING PROPERTY IN KROGER BEFORE LEAVING OUT. JACKSON, BEALS AND ROBINSON ARE SEEN GETTING INTO A WHITE SUV BEFORE TAKING OFF. SUSPECTS TOOK OFF FLEEING IN A WHITE JEEP COMPASS BEARING LOUISIANA N6313492. ON DUTY SUPERVISOR AND MAJOR CRIMES DETECTIVES WERE NOTIFIED. EMPLOYEES DID NOT HAVE ACCESS TO CAMERA FOOTAGE AT THIS TIME BUT COULD RETRIEVE IT TOMORROW.

OFFICERS ADVISED EMPLOYEES TO SAVE A COPY OF VIDEO FOOTAGE ON A FLASH DRIVE.

OFFICERS COMPLETED A BROADCAST FOR UNITS TO BE ON THE LOOK OUT FOR SUSPECTS. OFFICERS CIRCULATED AREA FOR SUSPECTS WITH NEGATIVE RESULTS.

NARRATIVE

OFFICERS RESPONDED TO THE AREA OF PINE-CONE DRIVE AND ARAPAHO TRAIL IN REFERENCE TO SHOTS FIRED INCIDENT, CONTACT WAS MADE WITH MONICA TROTTER AT 3518 ARAPAHO TRAIL, APARTMENT 27, WHO ADVISED SHE SHOT AT A MALE DRESSED IN ALL BLACK. MS. TROTTER ADVISED SHE HAD BEEN SEEING THE MALE SINCE APPROXIMATELY 0600 HOURS TODAY AND HIS ACTIONS APPEARED SUSPICIOUS. MS. TROTTER ADVISED THE MALE WALKED BACK EASTBOUND AND WESTBOUND ON ARAPAHO TRAIL SEVERAL TIMES AND APPEARED TO BE CASING THE AREA. MS. TROTTER ADVISED SHE OBSERVED THE MALE STANDING BEHIND A CITY TRASH CAN AT THE INTERSECTION OF PINEWOOD LOOP AND ARAPAHO TRAIL. MS. TROTTER ADVISED BECAUSE OF THE MALE'S ACTIONS, SHE RESPONDED INSIDE HER RESIDENCE AND RETRIEVED HER FIREARM (TAURUS 9MM SN: ABH797580). MS. TROTTER ADVISED WHEN SHE CAME BACK OUTSIDE, THE BLACK MALE WAS ATTEMPTING TO GET INSIDE THE LISTED VEHICLE. MS. TROTTER ADVISED SHE YELLED AT THE MALE TO GET HIS ATTENTION. SHE ADVISED HE POINTED A FIREARM AT HER, SO SHE FIRED SEVERAL TIMES AT THE MALE. SHE ADVISED THE MALE TOOK THE LISTED VEHICLE AND DROVE WESTBOUND TO THE INTERSECTION OF ARAPAHO TRAIL AND HILARO SPRINGS ROAD, WHERE HE EXITED THE VEHICLE AT 3604 ARAPAHO TRAIL, AND POINTED HIS FIREARM AT HER AGAIN. HE THEN RAN TO 3604 ARAPAHO TRAIL WHERE HE JUMPED THE FENCE ON THE WEST-SIDE OF THE HOUSE. MS. TROTTER ADVISED THE VEHICLE WAS STILL ROLLING, SO SHE ENTERED THE VEHICLE AND PLACED IT IN PARK, BUT EVENTUALLY DROVE THE VEHICLE BACK HOME. HER DAUGHTER, KENDRAE TROTTER, OWNS THE LISTED VEHICLE AND ADVISED HER PURSE WHICH CONTAINED HER KEYS AND PERSONAL INFORMATION, WAS STOLEN DURING AN AUTO B&E APPROXIMATELY TWO WEEKS AGO WHILE AT CLUB TABOO LOCATED AT 7200 COLONEL GLENN ROAD.

WHEN I ARRIVED, THE VEHICLE WAS BACKED IN AT 3518 ARAPAHO TRAIL. I OBSERVED AND LOCATED EIGHT SHELL CASINGS ON THE WEST-SIDE OF THE LISTED VEHICLE. THE VEHICLE'S LEFT REAR TIRE WAS FLAT AND TWO PROJECTILE STRIKES WERE OBSERVED AT THE REAR LIFT DOOR. I ALSO OBSERVED A BLACK FIREARM ON THE PORCH IN FRONT OF APARTMENT 27 WHERE MS. TROTTER WAS SITTING. I INQUIRED WHY THE FIREARM WAS THERE; SHE ADVISED THE FIREARM BELONGED TO THE MALE WHO STOLE THE LISTED VEHICLE WHICH HE DROPPED WHILE FLEEING. I ADVISED MS. TROTTER HER FIREARM WAS NEEDED AS A PART OF LRPD INVESTIGATION. SHE RETRIEVED HER FIREARM WITHOUT INCIDENT. I CONFISCATED BOTH FIREARMS, MADE THEM SAFE, AND SECURED THEM IN MY PATROL VEHICLE.

AT 3609 PINE-CONE DRIVE, CONTACT WAS MADE WITH, EDWIN AVILA, WHO ADVISED HEARING A COMMOTION AND LOOKING OUT HIS KITCHEN WINDOW TO FIND TWO BLACK MALES RUNNING THROUGH HIS YARD, WEST TO EAST. OFFICERS LOCATED A BLOOD TRAIL STRETCHING ACROSS THE BACK YARD AT 3609 PINE-CONE DRIVE FROM EAST TO WEST. OFFICERS LOCATED A CHEVROLET KEY FOB NEXT TO THE BLOOD TRAIL. MR. AVILA HAD VIDEO FOOTAGE OF AN INJURED MALE CRAWLING THROUGH HIS BACK YARD. IT APPEARS THE MALE CONTINUED EASTBOUND THROUGH THE YARD OF 3605 PINE-CONE DRIVE ONTO HILARO SPRINGS. OFFICERS SEARCHED THE IMMEDIATE AREA FOR THE MALE WITH NEGATIVE RESULTS. THERE WERE NO REPORTS OF ANY GUNSHOT VICTIMS AT ANY LOCAL MEDICAL FACILITY.

SERGEANT FINKS, SERGEANT MILLER, AND CSSU RESPONDED. BOTH FIREARMS WERE TRANSFERED TO CSSU.
