NARRATIVE

OFFICERS WERE DISPATCHED TO 3216 LEHIGH DRIVE IN REFERENCE TO AN AGGRAVATED ASSAULT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. CORWIN BIBBS.

MR. BIBBS ADVISED HE WAS IN THE NEIGHBORHOOD OF 23RD AND MAPLE VISITING WITH HIS GIRLFRIEND, MS. ELIZABETH TAYLOR, WHEN MR. TORRENCE TILLMAN, DOB: 09/01/1978, WALKED UP TO HIS VEHICLE AND ASKED FOR A CIGARETTE. MR. BIBBS ADVISED HE HAD BEEN SEEING MS. TAYLOR FOR APPROXIMATELY 2-3 MONTHS. MR. BIBBS ADVISED HE DOES NOT KNOW MS. TAYLOR'S ADDRESS OR PHONE NUMBER.

MR. BIBBS ADVISED HE HANDED HIM A CIGARETTE AND WAS RETRIEVING HIS LIGHTER FROM HIS POCKET WHEN MR. TILLMAN PULLED OUT A KNIFE, GRABBED HIM BY THE THROAT AND CHOKED HIM FOR APPROXIMATELY 5 SECONDS WHILE PULLING A KNIFE OUT. MR. BIBBS ADVISED MR. TILLMAN THEN STOLE HIS MONEY FROM HIS LEFT POCKET. MR. BIBBS ADVISED ONCE MR. TILLMAN GRABBED THE MONEY, HE IMMEDIATELY PULLED FORWARD TO CREATE SPACE BETWEEN THEM. MR. BIBBS ADVISED ONCE THE SPACE WAS CREATED, HE STOPPED THE VEHICLE AND EXITED IT.
