MR. BIBBS ADVISED HE WAS IN THE NEIGHBORHOOD OF 23RD AND MAPLE VISITING WITH HIS GIRLFRIEND, MS. ELIZABETH TAYLOR, WHEN MR. TORRENCE TILLMAN, DOB: 09/01/1978, WALKED UP TO HIS VEHICLE AND ASKED FOR A CIGARETTE. MR. BIBBS ADVISED HE HAD BEEN SEEING MS. TAYLOR FOR APPROXIMATELY 2-3 MONTHS. MR.
