NARRATIVE

WHILE ON PATROL, OFFICERS HEARD SEVERAL SHOTS BEING FIRED FROM THE AREA OF 9201 KANIS ROAD. OFFICERS QUICKLY RESPONDED TO THIS LOCATION. UPON ARRIVAL, OFFICERS WERE FLAGGED DOWN BY A WITNESS, BRYANT. BRYANT STATED SHE OBSERVED TWO MALES SHOOTING TOWARD A BLACK MALE IN THE PARKING LOT NEAR BUILDING #9. BRYANT DESCRIBED ONE SUSPECT AS BEING A SHIRTLESS WHITE MALE WEARING GREEN BASKETBALL SHORTS WITH A MASK COVERING HIS FACE. BRYANT DESCRIBED THE SECOND SUSPECT AS A SHIRTLESS MALE WEARING RED SHORTS WITH A MASK COVERING HIS FACE. BRYANT STATED BOTH SUSPECTS FLED ON FOOT TRAVELING WESTBOUND THROUGH THE APARTMENT COMPLEX. OFFICERS RESPONDED TO BUILDING #9 AND LOCATED SEVERAL SHELL CASINGS LYING ON THE GROUND. OFFICERS SET UP A PERIMETER AROUND THE SCENE USING CRIME SCENE TAPE. WHILE SEARCHING THE AREA, OFFICERS WERE APPROACHED BY THE VICTIM, PALMER. PALMER STATED HE WAS WALKING IN THE PARKING LOT TOWARD HIS LISTED CHRYSLER 300 WHEN HE OBSERVED TWO MASKED SUBJECTS WITH GUNS NEAR BUILDING #9. PALMER STATED HE FLED ON FOOT TOWARD BUILDING #10 WHEN THE TWO SUSPECTS BEGAN SHOOTING AT HIM. PALMER STATED HE WAS NOT INJURED DURING THE INCIDENT AND REFUSED MEDICAL ATTENTION. PALMER'S CHRYSLER 300 WAS STRUCK BY GUNFIRE DURING THE INCIDENT. OFFICERS LOCATED SEVERAL BULLET HOLES IN THE EXTERIOR WALL OF APARTMENT #10B AND #10J.
