NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A STOLEN VEHICLE REPORT. UPON ARRIVAL OFFICERS MADE CONTACT WITH MR. WESLEY VASQUEZ (VICTIM) WHO STATED HE WAS STOPPED AT THE RED LIGHT AT THE INTERSECTION OF BASELINE ROAD AND GEYER SPRINGS ROAD FACING WESTBOUND. MR. VASQUEZ SAID TWO UNKNOWN BLACK MALES WALKED UP TO HIS VEHICLE AND HIS DRIVER SIDE WINDOW WAS DOWN. MR. VASQUEZ ADVISED THE TALLER HEAVY SET BLACK MALE WITH LONG DREADS AND FULL BEARD (SUSPECT 1) HIT HIM ON THE LEFT SIDE OF HIS FACE AND PULLED HIM OUT OF HIS 2016 WHITE HYUNDAI ELANTRA. MR. VASQUEZ STATED THE SHORT BLACK MALE WEARING A WHITE SHIRT AND LONG DREADS KICKED HIM ON THE RIGHT SIDE OF HIS RIBS AND THEN JUMPED INTO THE VEHICLE AND LEFT LAST SEEN WEST ON BASELINE ROAD. MR. VASQUEZ STATED HE WAS LIVING OUT OF THE VEHICLE HE HAD JUST BOUGHT FROM SOMEONE ABOUT FIVE DAYS AGO. MR. VASQUEZ SAID ALL OF HIS CLOTHING, HIS PHONE, AND WALLET CONTAINING HIS I.D., SOCIAL SECURITY CARD, AND DEBIT CARD WAS INSIDE OF THE VEHICLE. MR. VASQUEZ ADVISED HE COULD NOT PROVIDE THE PLATE NUMBER, VIN, OR ANY FURTHER INFORMATION ON THE VEHICLE BESIDES THE IDENTIFYING MARKER OF A STICKER ON THE GAS CAP. OFFICERS MADE A BROADCAST OF THE VEHICLE AND SUSPECTS DESCRIPTION. MEMS RESPONDED AND TRANSPORTED MR. VASQUEZ TO UAMS FOR TREATMENT. BWC IN USE.
