2. Opening Comments

- 2. **Staff Liaison** Christopher Harvey, Senior Advisor to the Mayor
- 3. Department Liaison Chief Helton, Chief of Police briefed us on the steps taken following the national events of the weekend. The LRPD has communicated with RNC and DNC of Arkansas, increased the patrols, and integrated DNC cameras into the system. They will hold quarterly meetings with officials. There is also a LRPD Recruit graduation on July 25th at 10am.

He also shared school year preparations. He briefed the commission on upcoming preparations for an Arkansas Razorbacks game playing on a Thursday (August 29th) at War Memorial Stadium, the State Fair October dates, the upcoming Election on November 5th.

Commissioner Burris had a question about school openings - Chief Helton verified that there are SRO's at all middle and high school

# Discussion by Commissioner Thompson – Community Safety Research (Freedom Fund)

- H.O.P.E. Advisory Council's findings. Rev Burris There were a set of recommendations from the council, including the formation of this commission. The council found that there were so many programs and commissions doing different things. The question was raised to see if there is a way to bring those things together to either work in concert or in duplicity to reach more people around the city. Move to adopt an idea of collaboration.
- Commissioners would like to recommend review of Lighting in neighborhoods, Abandoned homes, and availability of Affordable Housing.
- 3. Many of those strategies that came from the council have been implemented through Ordinances in the City.
- Commissioner Herts mentioned R.O.C.K. Academy, which provided valuable information to help citizens become more familiar with city operations.
- 5. Commissioner Burris shared an example of Kroger on Col Glenn and the reason for its closing theft main cause. What can we do to eradicate things that hinder safety and growth?
- 6. Commissioner Hobbs shared that security was lacking. Visibility of police officers is a deterrent of crimes.
- 7. Chief Helton added social workers will have 6 in 2 weeks | added youth component | crime victim follow-up communications | 21st Century Division youth programs \*\*Sales Tax will be very helpful for that. Crisis Intervention partnership has also been formed.
- 8. Commissioner Hobbs inquired if weekly task force meetings would help with better communication amongst stakeholders?

## 2. Brainstorming Session - Open Discussion by Commissioners

- 1. Ideas to be presented to the Little Rock Board of Directors
  - Commissioner Hobbs would like to recommend that the weekly task force meetings for community organizations and programs be reviveed so that everyone is informed. Prevention and Intervention - communicating what's available. GVI - Group Violence Intervention (Casey Beard) DOJ program. Can a resource guide be formed that can provide awareness about available programs? Commissioner Charles - suggested putting a esource page on the website.
  - 2. Commissioner Charles suggested conducting a brief Survey 2 questions What Ward do you live in? What does change look like

- for you? Community Feedback survey. The community doesn't know we are meeting. Can we do a data share with the Freedom Fund so we are not reinventing the wheel. Citizens Connect; Can we livestream meetings to spread awareness?
- 3. Commissioner Hobbs find more programs for children that are in trouble. Failing School, Suspension Prevention, Minor Crimes; Sustainability is an issue; Support effective intervention programming for children. How do we provide support for Adults -Substance abuse issues?
- 4. City population demographic 65,000 individuals (0-24 in age) 1/3 of the population.
- 5. Commissioner Ward asked if there is a Youth Services Office? A Central point of contact. Could there possibly be a Children and Youth Commission?

A few additional ideas that were circulated included City-wide Communication - PSAs, PIT, More collaboration with other commissions to remove duplicity.

Rights After Wrongs - SemiAnnual - Free Legal clinics - Better Communication

Commissioner Doyle mentioned Infraguard, which is a resource that connects FBI and citizens with information about how systems work and vital information about ongoing situations and alerts.
