#### Director's Report:

- Two Rivers Trail item was approved by the Board of Directors.
- Parks upcoming Board of Director's meeting agenda items:
  - ❖ West Central Ballfield Complex– will be utilizing Board approved ARPA funds.
  - ❖ I-30 Crossing Project – will be utilizing ARPA funds for Masterplan. Selection process has been completed.
- Hindman Park – Three (3) public meetings have been completed at Hindman Park Pro Shop. There were 30 to 50 people present at each meeting. Overall received feedback from 100 people. Will start master planning process based on collected feedback.

## Staff Reports

- Chairman France asked questions about Archery range at Murray Park funding.
  - ❖ Deputy Director of Operations, Justin Dorsey advised that funding is through the Outdoor Recreation grant. Waiting for confirmation of award.
  
- Commissioner Smith asked questions about the state of planning on the I-30 Crossing Project.
  - ❖ Parks Director Couch advised that plans have not been completed for the project and it would be for a firm to complete a plan first. The plan that has been completed is the Downtown Master Plan.
  
- Commissioner Bernardo suggested that the underpass area would be a good place for Pickleball.
  - ❖ Parks Director Couch advised that there will be upcoming community meetings and to come and share that input.
  
- Question about Pankey Park Ribbon cutting schedule.
  - ❖ Advised that Ribbon cutting event has not been rescheduled.
  
- Chairman France asked about Razorback games cleanup.
  - ❖ Director Couch advised that the City of Little Rock maintains the park area and the state cleans up after the games.
  
- Commissioners Bernardo and Smith asked questions about the upcoming Senior center.
  - ❖ Director Couch advised that the Senior center was funded by ARPA funds for 3 million. Currently working on design plans with Polk Stanley. Age Friendly Commission also provided input.
  - ❖ Deputy Director Craig advised about tentative facility programming, staffing, and hours.
  
- Director Couch advised of recent challenges due to theft and vandalism.
  
- Commissioner Fletcher asked what the Parks Commission can do to assist.
  - ❖ Recreation Coordinator Marbley advised of the challenges, what the barriers are and how the program functions.
