FLORES MADE A PHONE CALL AND AN UNKNOWN HISPANIC FEMALE INTERPRETED. FLORES ADVISED HE WAS ROBBED AT GUN POINT OF HIS WALLET BY 3 BLACK MALES ALL WEARING ALL BLACK, EXCEPT ONE THAT HAD A REFLECTIVE VEST, WHILE HE WAS ENTERING THE ARKANSAS STATE FAIR AT ROOSEVELT AND HOWARD. FLORES WAS UNABLE TO GIVE A BETTER DESCRIPTION. FLORES ADVISED HIS WALLET CONTAINED HIS ID, TWO CREDIT CARDS, AND APPROXIMATELY 170 DOLLARS IN CASH.

OFFICERS PROVIDED AN INCIDENT NUMBER.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A SHOOTING CALL. ON SCENE, OFFICERS CLEARED THE PROPERTY OF ANY THREATS AND OBSERVED A BLACK CHEVROLET IMPALA WITH WHAT APPEARED TO BE TWO BULLET HOLES IN THE PASSENGER SIDE OF THE VEHICLE.

OFFICERS MADE CONTACT WITH CALVIN HORTON AND DEBRAH TAYES, WHO ADVISED THAT THEY WERE ASLEEP INSIDE OF THE GRAND DESIGN IMAGINE CAMPER ON THE PROPERTY. HORTON STATED THAT THEY WERE WOKEN UP BY MULTIPLE GUNSHOTS AND THEIR DOGS BARKING. HORTON ADVISED HE WALKED OUTSIDE OF THE CAMPER BUT DID NOT OBSERVE THE INDIVIDUAL THAT WAS SHOOTING. HE STATED THAT HIM AND TAYES GOT INTO THEIR VEHICLE AND DROVE TO CASEY'S GAS STATION AT 8818 KANIS ROAD BEFORE REQUESTING FOR OFFICERS.

UPON FURTHER INVESTIGATION, OFFICERS FOUND BULLET FRAGMENTS UNDERNEATH THE IMPALA'S REAR BUMPER. MULTIPLE SHELL CASINGS WERE LOCATED TO THE NORTH OF THE GATE TO THE PROPERTY ON DORCHESTER DRIVE. OFFICERS CIRCULATED THE OUTSIDE OF THE CAMPER BUT DID NOT OBSERVE ANY SIGNS THAT BULLETS HAD STRUCK THE CAMPER. A SUPERVISOR WAS CONTACTED AND RESPONDED TO THE SCENE. OFFICERS COLLECTED THE BULLET FRAGMENTS AND SHELL CASINGS TO STORE AS EVIDENCE. MVR AND BWC WERE IN USE.
