ON TODAY'S DATE COMMUNICATIONS RECEIVED A CALL IN REGARD TO A DISTURBANCE WITH A WEAPON.

UPON ARRIVAL, OFFICERS SPOKE WITH SAMUEL MOORE WHO STATED CHARNETTE SMITH PULLED A BUTCHER KNIFE ON HIM AND DEMANDED HE GIVE HER \$10.00. MOORE STATED HE WAS LOOKING FOR A PLACE TO REST WHEN SMITH OFFERED TO LET HIM STAY IN HER ROOM FOR \$10.00. MOORE STATED ONCE HE LOOKED AT THE SMITH'S RESIDENCE, HE TOLD HER HE DID NOT WANT TO STAY IN HER ROOM. MOORE STATED SMITH BECAME ANGRY, PULLING OUT A KNIFE AND DEMANDING HE GIVE HER \$10.00. **NARRATIVE**

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION FOR A BATTERY CALL. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE VICTIM, DIXIE LYMAN. SHE ADVISED THAT SHE WAS ATTEMPTING TO STOP TWO SUSPECTS FROM STEALING A SHOPPING CART FULL OF MERCHANDISE.

SHE ADVISED THAT THE TWO SUBJECTS, LATER IDENTIFIED AS PAULISHA WILLIAMS AND JAMES DICKSON, PASSED ALL POINTS OF PURCHASE AND WHILE MS. LYMAN INTERVENED WITH THEM AT THE FRONT DOORS, MS. WILLIAMS PUNCHED HER IN THE FACE. SHE ADVISED THAT AFTER THIS, SHE LEFT THE STORE AND ENTERED A 2012 FORD EXPLORER (AR LPN AUS10J) AND FLED IN AN UNKNOWN DIRECTION.

MS. WILLIAMS ADVISED SHE DID HAVE VISIBLE INJURY AND DID NOT REQUIRE MEDICAL ATTENTION. MR. FANN, THE ASSISTANT MANAGER OF THE KROGER, ADVISED THAT HE WITNESSED THE ROBBERY AND ADVISED OF THE SAME EVENTS.

OFFICERS PROVIDED KNOWN SUSPECT INFORMATION TO OTHER OFFICERS AND THE VEHICLE WAS LOCATED AT 10300 NORTH RODNEY PARHAM ROAD UNOCCUPIED. OFFICERS REMAINED WITH THE VEHICLE UNTIL SUBJECTS MATCHING THE DESCRIPTION PROVIDED BY MS. LYMAN AND MR. FANN APPROACHED THE VEHICLE. OFFICERS VIEWED THE SUBJECTS BEGIN TO PLACE ITEMS INTO THE VEHICLE.

OFFICERS PROCEEDED TO MAKE CONTACT WITH THE SUBJECTS AND OBSERVED THEM ALL ENTER THE VEHICLE RAPIDLY. THE VEHICLE REVERSED INTO A PATROL VEHICLE WHILE OFFICER CHASE STREET WAS EXITING THE VEHICLE, STRIKING THE VEHICLE'S DRIVER FRONT FENDER. OFFICERS SEARCHED THE VEHICLE FOR EVIDENCE OF THE ROBBERY AND LOCATED A SILVER BRYCO ARMS HANDGUN (SN: 1213028) ON THE FLOORBOARD OF THE REAR DRIVER'S SEAT WHERE MR. HAMPTON WAS SEATED. OFFICERS ALSO LOCATED A BLACK SMITH AND WESSON M&P SHIELD HANDGUN (SN: LFK1426) IN MS. JAMES' PURSE IN THE VEHICLE. OFFICERS ALSO RECOVERED THE BLACK HOODIE AND BLACK BONNET THAT MS. WILLIAMS WAS WEARING DURING THE ROBBERY.

OFFICERS HAD THE SUSPECT VEHICLE TOWED TO THE CITY IMPOUND PER DEPARTMENTAL POLICY.

MS. WILLIAM'S COUSIN, KRYSTAL PETERS, TOOK CUSTODY OF JUV-VIC-1 WHILE OFFICERS WERE ON SCENE.

OFFICERS TRANSPORTED ALL SUBJECTS TO THE 12TH STREET DETECTIVE'S OFFICE FOR DETECTIVE INTERVIEWS. OFFICERS HAD MS. LYMAN AND MR. FANN DRIVE TO THE 12TH STREET DETECTIVE'S OFFICE FOR INTERVIEWS.

AFTER DETECTIVE'S INTERVIEWS, MR. WALKER WAS RELEASED WITHOUT CHARGES.

MS. WILLIAMS WAS CHARGED WITH ROBBERY (B FEL), THEFT OF PROPERTY (C FEL), AND WAS SERVED WITH A CONTEMPT OF COURT WARRANT (LR-24-8008).

MR. DICKSON WAS CHARGED WITH ROBBERY (B FEL), AND THEFT OF PROPERTY (C FEL).

MS. JAMES WAS CHARGED WITH FLEEING (C FEL), AGGRAVATED ASSAULT ON A LAW ENFORCEMENT OFFICER (D FEL), ENDANGERING THE WELFARE OF A MINOR X2 (D FEL), AND CRIMINAL MISCHIEF (A MIS).

MR. HAMPTON WAS CHARGED WITH POSSESSION OF A FIREARM BY CERTAIN PERSONS (B FEL), AS HE WAS FOUND TO BE SERVED WITH A NO CONTACT ORDER (ORDER #22-294) ORDERING HIM TO NOT POSSESS A FIREARM WHICH HE POSSESSED DURING THE COURSE OF A CRIME.
