OFFICERS WERE DISPATCHED TO THE LISTED LOCATION FOR A ROBBERY CALL AT THE TARGET. OFFICERS MADE CONTACT WITH VICTIM 2. MR. D. MACK (CLERK), WHO STATED WHILE HE WAS WORKING AT THE ELECTRONICS DEPARTMENT, A BLACK MALE SUSPECT APPROACHED HIM AND DEMANDED A GAME CONSOLE. HE SAID WHEN THE SUSPECT PUT HIS HAND INSIDE HIS JACKET POCKET AND POINTED TOWARDS HIM. HE ASSUMED THE SUBJECT HAD A GUN AND GOT SCARED. HE SAID THE SUSPECT THEN TOOK HIM TOWARDS THE GAME CONSOLE CABINET AND FORCED HIM TO OPEN THE CABINET AND GOT THE LISTED ITEM AND FLED THE AREA IN AN UNKNOWN DIRECTION. WHILE ON THE SCENE, THE MANAGER ADVISED THAT ANOTHER BLACK MALE SUBJECT, MR. WESSON (SUSPECT 2), WAS ACTING VERY SUSPICIOUS AND COULD POSSIBLY BE WITH THE 1ST ROBBERY SUSPECT BUT SHE WAS NOT SURE. OFFICER N. PLUMMER DETAINED THE SECOND SUSPECT, MR. WESSON, UNTIL FURTHER INVESTIGATION. AFTER CONDUCTING A RECORDS CHECK ON THE SUBJECT, HE SHOWED TO HAVE A FELONY WARRANT (FTA) OUT OF THE PULASKI COUNTY SHERIFF'S OFFICE (WARRANT NUMBER PC 231809 FTA). SGT. PLUNKETT WAS ADVISED AND DETECTIVE MCVAY RESPONDED TO THE SCENE AND INTERVIEWED THE VICTIM AND REVIEWED THE VIDEO, AFTER REVIEWING THE VIDEO, IT WAS DETERMINED MR. WESSON WAS NOT ASSOCIATED WITH THE ROBBERY. HE WAS LATER TRANSPORTED TO THE PULASKI COUNTY REGIONAL JAIL FOR BOOKING ON HIS WARRANT BY OFC. N. PLUMMER. CRIME SCENE RESPONDED AND PROCESSED THE SCENE. A BROADCAST WAS ISSUED BY OFFICER PLUMMER. BWC WAS IN USE.
