#### **NARRATIVE**

ON 10/24/2024, OFFICERS RESPONDED TO THIS LOCATION IN REFERENCE TO A DISTURBANCE WITH A WEAPON.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH JUVENILE VICTIM 1, WHO STATED HE WAS SITTING IN A VEHICLE IN THE PARKING LOT AT THIS LOCATION WITH JUVENILE SUSPECT 1 AND JUVENILE SUSPECT 2. JV1 STATED HE BRAGGED TO JS1 AND JS2 THAT HE "GOT PAID HUNDREDS OF DOLLARS" AND ASKED WHERE THEY WERE GOING. JV1 STATED AT THAT POINT JS1 STUCK A HANDGUN TO HIS CHEST AND DEMANDED HIS MONEY AND PHONE. JV1 STATED JS1 ALSO STATED HE WOULD KILL HIM. JV1 STATED AT THAT TIME HIS MOM (MECHIEL LEBLUE), PULLED THROUGH THE PARKING LOT AND JS1 AND JS2 FLED THE SCENE NORTHBOUND ON FOOT.

OFFICERS SPOKE WITH MS. LEBLUE, WHO STATED SHE PULLED THROUGH THE PARKING LOT AND WITNESSED TWO INDIVIDUALS ATTEMPTING TO ROB HER SON. MS. LEBLUE STATED JS2 WAS HOLDING JV1 FROM BEHIND, WHILE JS1 HELD A GUN TO HIS CHEST.

OFFICERS MADE CONTACT WITH MS. TIFFANY HUDSON, WHO STATED JS2'S PHONE WAS STILL PINGING AT THE PROPERTY WHERE THIS INCIDENT OCCURRED. OFFICERS CANVASED THE AREA AND DISCOVERED THE PHONE WAS STILL IN THE VEHICLE WHERE THIS INCIDENT OCCURRED.

THE VEHICLE WHERE THIS INCIDENT OCCURRED WAS A BLACK IN COLOR MERCEDES-BENZ 4 DOOR SEDAN THAT WAS PARKED ON THE SOUTHERN SIDE OF THE APARTMENT BUILDING.

JV1 SHOWED OFFICERS PICTURES AND VIDEOS OF JS1 AND JS2 HOLDING THE HANDGUN USED IN THIS INCIDENT AND SENT THE PICTURES TO OFFICERS.

OFFICERS RECEIVED A BLACK BACKPACK WHICH CONTAINED 19 LIVE ROUNDS OF 45 CALIBER AMMO AS EVIDENCE FROM MS. LEBLUE WHICH WAS CLAIMED TO BELONG TO JS1. THE EVIDENCE WAS TRANSPORTED THE NORTHWEST SUBSTATION'S PROPERTY ROOM AND STORED AS EVIDENCE.
