NARRATIVE

ON 10/23/2024, OFFICERS RESPONDED TO THIS LOCATION IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL REPORT.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. CAMERON MAY, WHO INITIALLY STATED HIS EX-GIRLFRIEND, MS. TANEEKA HARMON PICKED HIM UP FROM HIS APARTMENT AND TOOK HIM TO KANIS PARK. MR. MAY STATED WHILE THEY WERE SPEAKING, ONE OF MS. HARMON'S FRIENDS APPROACHED THEM AND DEMANDED MR. MAY'S PHONE. MR. MAY STATED WHEN HE REFUSED TO GIVE HIS PHONE, MS. HARMON'S FRIEND PULLED A GUN ON HIM. MR. MAY STATED HE RECOGNIZED THE GUN AS MS. HARMON'S GUN. MR. MAY STATED WHILE THIS WAS GOING ON ANOTHER FRIEND OF MS. HARMON'S WAS SITTING IN A "RED VAN".

MR. MAY IDENTIFIED MS. HARMON'S FRIEND AS MR. MIKE POTWSKI.

MR. MAY LATER STATED HE CALLED HIS EX-GIRLFRIEND AND THREATENED TO EXPOSE HER FOR CHEATING AT MEDICAL SCHOOL AT UAMS BECAUSE SHE GAVE HIM A SEXUALLY TRANSMITTED DISEASE. MR. MAY THEN STATED MS. HARMON STATED SHE WANTED TO SPEAK WITH HIM IN PERSON AT KANIS PARK AND GAVE HIM A RIDE THERE.

WHEN OFFICERS ASKED ABOUT MS. HARMON'S CLOTHES, MR. MAY INITIALLY STATED HE WAS UNABLE TO TELL BECAUSE OF HOW DARK IT WAS. MR. MAY LATER STATED MS. HARMON MIGHT HAVE BEEN WEARING A RED UAMS SHIRT AND LEGGINGS THAT COULD HAVE BEEN BLACK OR PLAID.

WHEN OFFICERS ASKED ABOUT THE GUN THAT WAS USED IN THIS INCIDENT, MR. MAY COULD NOT GIVE OFFICERS A DESCRIPTION OF THE GUN.

WHEN ASKED ABOUT THE VEHICLE INVOLVED IN THIS INCIDENT, MR. MAY STATED MS. HARMON GOT INTO A BLACK 2020 HYUNDAI ELANTRA AND THE TWO MALES INVOLVED LEFT THE SCENE IN THE "RED VAN". OFFICERS SEARCHED FOR MS. HARMON'S VEHICLE ON ACIC AND DISCOVERED THAT IT WAS A BLUE 2014 HYUNDAI ACCENT.

UPON ADDITIONAL INVESTIGATION OFFICERS DISCOVERED THAT AN ORDER OF PROTECTION WAS PLACED IN EFFECT ON 10/23/2024 BETWEEN MR. MAY AND MS. TANEEKA. WHEN OFFICERS QUESTIONED MR. MAY ABOUT THIS, HE STATED HE HAD NO INFORMATION ABOUT IT BECAUSE HE "HAD NOT BEEN SERVED".
