ON 10/26/2024, OFFICERS NELSON AND BREAKFIELD RESPONDED TO THE LISTED ADDRESS FOR A REPORT OF A STOLEN VEHICLE. OFFICERS MADE CONTACT WITH SAM ALTON WHO ADVISED HE WAS DRIVING VEHICLE NEAR THE AREA OF 8601 TEDBURN WHEN HE OBSERVED HIS BED COVER WAS LOSE. MR. ALTON STATED HE EXITED HIS VEHICLE TO REATTACH THE COVER WHILE AT THE INTERSECTION OF TEDBURN DRIVE AND MERRIVALE DRIVE. MR. ALTON SAID THAT AT THIS TIME SUSPECT 1 ENTERED INTO HIS VEHICLE AND ATTEMPTED TO DRIVE AWAY. MR. ALTON ADVISED HE GRABBED ONTO THE VEHICLE IN AN ATTEMPT TO FORCE THE SUSPECT OUT. MR. ALTON CLAIMED THE SUSPECT THEN ACCELERATED IN RESPONSE, CAUSING HIM TO BE THROWN FORCEFULLY TO THE GROUND. AT THE TIME OF CONTACT MR. Supplemental Information

On 10/26/2024 at approximately 1302 HRS, Officer Steele and I responded to the 5100 block of W. 10th St. in reference to a suspicious vehicle. When I arrived on scene, I observed a white Chevrolet truck(vehicle 1) backed into the driveway of the abandoned house located at 5108 W 10th St. The truck was displaying Arkansas license plate 154ZTT. I was aware of the broadcast that had been made by Officer Breakfield concerning a robbery and theft involving vehicle 1. I confirmed that the truck was reported stolen. I contacted Det. Kaufman about the vehicle recovery and circumstances surrounding its theft. I was advised to tow vehicle 1 to the crime scene bay for processing. While I was on scene, contact was made with M. Longfellow (contact 1). M. Longfellow stated that he observed an unknown black male walk away from the truck after it was parked and then entered the passenger side of a black Chevrolet Impala. M. Longfellow did not have any additional information about the suspect. M. Longfellow was able to provide video footage that will be attached to the report. Adams towing responded to my location to remove the truck and transport it to the crime scene bay. S. Alton was notified that his truck was recovered and was going to be processed for evidence. A copy of the tow slip was provided to the CSSU office. An email was sent to ACIC Entries and Deletions in order to remove the vehicle from ATLAS as stolen status.

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A ROBBERY REPORT.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH ZABRYN FOGLE, WHO ADVISED HE WAS JUST ROBBED AT GUNPOINT. FOGLE SEEMED TO BE UNDER THE INFLUENCE OF SOME SORT OF INTOXICANT.
