NARRATIVE

ON NOVEMBER 9, 2024, OFFICERS WERE DISPATCHED TO THE LISTED ADDRESS DUE TO A CRIMINAL MISCHIEF. UPON ARRIVAL, CONTACT WAS MADE WITH MS. MAX AND MS. RAMOS. MS. MAX STATED SHE WAS IN BED AND HEARD SHOTS FIRED OUTSIDE OF HER TRAILER AT APPROXIMATELY 0145 HOURS. SHE STATED SHE SAW A WHITE FLASH AND GOT SCARED AND STAYED IN BED. SHE STATED SHE DID NOT CALL POLICE AT THAT TIME. MS. MAX STATED SHE WOKE UP THIS MORNING AND NOTICED HER MOBILE HOME WAS SHOT UP. OFFICERS OBSERVED SEVERAL HOLES ON THE BRICK WALL AND WINDOW IN THE LIVING ROOM. OFFICERS WALKED OUTSIDE AND NOTICED FOUR SPENT CASINGS ON THE GROUND NEAR LOT 163 AND ONE ON THE FRONT DECK. 1L37 AND A MAJOR CRIMES DETECTIVE WAS NOTIFIED.

OFFICERS WENT TO LOT 163 TO MAKE CONTACT WITH THE RESIDENT. CONTACT WAS MADE WITH MR. RODRIGUEZ. MR. RODRIGUEZ STATED HE IS IN A RELATIONSHIP WITH A MARRIED FEMALE. HE STATED HE DID NOT KNOW SHE WAS MARRIED WHEN THEY MET. HE STATED HE WAS HOME DRINKING WHEN HIS GIRLFRIEND'S HUSBAND WENT TO HIS HOME AND WAS KNOCKING VERY AGGRESSIVELY. HE STATED HE DID NOT GO OUTSIDE BECAUSE HE WAS AFRAID. MR. RODRIGUEZ STATED HE HEARD THE SHOTS BEING FIRED OUTSIDE HIS TRAILER BUT DIDN'T KNOW WHAT GOT HIT. HE STATED HE DID NOT CALL POLICE AT THIS TIME. MR. RODRIGUEZ STATED HE DOES NOT KNOW THE SUSPECTS NAME AND ALL HE KNOWS IS THAT THE SUSPECT IS FROM NICARAGUA.

A MAJOR CRIMES DETECTIVE AND CSSU ARRIVED AND PROCESSED THE CRIME SCENE. MS. MAX WAS GIVEN THE REPORT NUMBER AND WAS ADVISED TO CALL BACK IF SHE NEEDED FURTHER ASSISTANCE. BWC WAS IN USE.
