OFFICERS RESPONDED TO THE LISTED LOCATION REGARDING TERRORISTIC ACT JUST OCCURRED. OFFICERS MADE CONTACT WITH VIC#1 Marked ADVISED THAT THESE TWO GIRLS, SUS#4(NINA) AND SUS#5(LATRESE), WERE PICKING ON A FRIEND OF HERS SO SHE DECIDED TO CONFRONT THEM ABOUT IT. EBONI ADVISED SHE CALLED THEM ON THE PHONE AND TOLD THEM TO JUST LEAVE THE GIRL ALONE. EBONI STATED NINA AND LATRESE DECIDED TO WALK OVER TO HER APARTMENT INSTEAD. THEY ALL LIVE IN THE SAME APARTMENT COMPLEX. MARKED ADVISED LATRESE KNOCKED ON THE DOOR AND WHEN SHE OPENED IT, SHE SAW LATRESE, NINA, SUS#1(CAMERON), SUS#2(GUAP) AND SUS#3(UNKNOWN B/M). ALL THE YOUNG MEN STAY IN THE COMPLEX AS WELL.
