NARRATIVE

CASTILLO GET IN THE CLOSET INSIDE THE OFFICE. THE SUSPECT TOOK AN UNDISCLOSED AMOUNT OF MONEY FROM THE SAFE AND FLED THE LOCATION ON FOOT IN AN UNKNOWN DIRECTION OF TRAVEL. MR. COCHRAN ADVISED THE SUSPECT WAS WEARING RED AND BLACK GLOVES. MR. COCHRAN ADVISED THE SUSPECT WAS WEARING A BLACK SKI MASK WITH A PICTURE ON THE FRONT OF THE MASK. 3L35 WAS NOTIFIED AND RESPONDED TO THE LOCATION. OFFICERS CIRCULATED THE AREA WITH NEGATIVE RESULTS. NARRATIVE

OFFICERS WERE DISPATCHED TO 1208 S BOWMAN ROAD (SMOKER'S CAVE) IN REFERENCE TO A ROBBERY OF A BUSINESS. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE CALLER, AKANSHA MERCHANT (EMPLOYEE). MERCHANT ADVISED THAT AT APPROXIMATELY 1645 HOURS ON 11/12/2024, A B/M SUSPECT CAME INTO THE STORE AND POINTED A GUN AT HER HEAD, TELLING HER TO GIVE HIM THE MONEY OUT OF THE REGISTER. MERCHANT STATED THAT THE SUSPECT THEN CAME AROUND THE COUNTER AND TIED HER HANDS UP WITH TAPE. MERCHANT ADVISED SHE SAT IN THE CORNER OF THE STORE WHILE THE SUSPECT TOOK THE MONEY FROM THE REGISTER, THEN ENTERED THE BACK OF THE STORE AND TOOK MONEY OUT OF A BOX. MERCHANT STATED THE SUSPECT THEN LEFT THE STORE AND GOT IN THE PASSENGER SIDE OF A DARK GREEN TOYOTA FOUR RUNNER. MERCHANT STATED THAT THERE WAS ANOTHER MALE IN THE DRIVER'S SEAT OF THE VEHICLE. MERCHANT ADVISED SHE DID NOT SEE THE DIRECTION THE VEHICLE LEFT IN. MERCHANT ADVISED THAT APPROXIMATELY 1 HOUR PRIOR TO THE ROBBERY, THE SUSPECT ENTERED THE STORE AND ASKED TO LOOK AROUND. MERCHANT STATED PRIOR TO THE SUSPECT LEAVING, HE STATED, "I WILL BE BACK."
