**NARRATIVE**

OFFICERS RESPONDED TO A BATTERY IN PROGRESS AT THE LISTED ADDRESS. UPON ARRIVAL OFFICERS SAW S1, MS. LARAYJAH GAY, AND S2, MR. ERIC ALEXANDER, WALKING AWAY FROM V1, MS. KIRSTIN RILEY. MS. RILEY ADVISED BOTH MS. GAY AND MR. ALEXANDER ATTACKED HER BECAUSE SHE WAS KEEPING MS. GAYS KEYS AWAY FROM HER DUE TO MS. GAY BEING INTOXICATED AND TRYING TO DRIVE HOME EARLIER. OFFICERS RESPONDED OUT THERE PREVIOUSLY WHERE BOTH MS. GAY AND MS. RILEY AGREED THAT MS. RILEY SHOULD HOLD ONTO MS. GAYS KEYS WHILE SHE SOBERS UP BEFORE DRIVING.

WITNESS 1, MS. AMANDA SMITH, APPROACHED OFFICERS AND ADVISED SHE SAW BOTH SUSPECTS ATTACK MS. RILEY. MS. SMITH STATED SHE WAS THE UBER DRIVER FOR MR. ALEXANDER. UPON LEAVING THE UBER DRIVERS VEHICLE MR. ALEXANDER GOT INTO A BUSH AND JUMPED ON MS. RILEY CHOKING HER TILL SHE PASSED OUT AND PUNCHED HER MULTIPLE TIMES. WHILE SHE WAS UNCONSCIOUS BOTH SUSPECTS WENT THROUGH MS. RILEY'S POCKETS AND TOOK HER CELL PHONE ALONG WITH TAKING BACK MS. GAYS KEYS. OFFICERS CALLED MEMS FOR ALL SUBJECTS INVOLVED MEDICAL WAS REFUSED BY THE SUSPECTS. MS. RILEY WAS CLEARED BY MEMS. OFFICERS ARRESTED MS. GAY AND MR. ALEXANDER. WHILE SEARCHING MS. GAY, OFFICERS FOUND MS RILEYS PHONE IN HER POCKET. BOTH WERE TRANSPORTED TO THE 12TH STREET DETECTIVES' OFFICE ALONG WITH THE WITNESS AND VICTIM. DURING THE TRANSPORT MS. GAY BEGAN TO MAKE THREATS TOWARD MS. RILEY. STATING SHE WOULD BEAT THE VICTIM UP AGAIN AFTER BEING RELEASED FROM JAIL. MS. RILEY AND MS. GAY USED TO BE IN AN EXTENDED INTIMATE RELATIONSHIP.

AFTER MEETING WITH DETECTIVES MS. GAY WAS TRANSPORTED TO PCRJ AND BOOKED ON THE CHARGES OF DOMESTIC BATTERY 3RD, ROBBERY, AND TERRORISTIC THREATENING. MR. ALEXANDER WAS ALSO TRANSPORTED TO PCRJ AND BOOKED ON THE CHARGES OF ROBBERY AND AGGRAVATED ASSAULT. MR. ALEXANDER'S KEYS WERE GIVEN TO HIS MOTHER WITH HIS CONSENT. BODY CAMERA AND MVR IN USE.
