SHE SAID HE WENT INTO THE BATHROOM AND TOOK A SHOWER AND WHEN HE CAME OUT HE WAS MEAN. SHE SAID HE TOLD HER TO CASH APP HIM SOME MONEY BUT SHE DID NOT HAVE HER GLASSES SO SHE COULD NOT SEE WELL ENOUGH TO DO IT. SHE SAID HE BECAME ANGRY AND PUSHED HER AGAINST THE WALL. SHE SAID THAT HE STRUCK HER IN THE FACE AND THEN TOOK HER CELL PHONE AND CAR KEYS. MS. BRADFIELD SAID THAT HE THEN TOOK HER VEHICLE AND DROVE AWAY. SGT. HEFNER AND MAJOR CRIMES WERE NOTIFIED. A BROADCAST WAS MADE WITH NEGATIVE RESULTS. SUSPECT 1'S CLOTHING WAS STORED.
