NARRATIVE

I, OFFICER MONTGOMERY #41723 RESPONDED TO 4200 SOUTH UNIVERSITY AT THE WAFFLE HOUSE FOR A ROBBERY ALARM. THE CALL NOTES STATED A HISPANIC MALE WAS INSIDE OF THE BUSINESS AND NOT LEAVING.

UPON ARRIVAL, I MADE CONTACT WITH MR. RONALD SOLIS WHO SPOKE ONLY SPANISH. DUE TO MR. SOLIS SPEAKING ONLY SPANISH, ALL COMMUNICATION WAS THROUGH OFFICER GALLEGOS. MR. SOLIS ADVISED OFFICER GALLEGOS THAT HE HAD BEEN ROBBED BY THE LISTED SUSPECTS. MR. SOLIS STATED HE HAD BEEN GIVEN A RIDE BY THE LISTED SUSPECTS WHO HE ALSO WORKS WITH. MR. SOLIS STATED THAT SUSPECT 1, MR. OSMAN JONAS WAS SITTING IN THE BACKSEAT WITH HIM WHEN VEHICLE 1 CAME TO A STOP BEHIND THE LISTED INCIDENT ADDRESS (WALGREEN'S).

MR. SOLIS TOLD OFFICER GALLEGOS THAT MR. JONAS PUNCHED HIM IN THE FACE AND ALSO BIT HIS FINGER WHILE STEALING HIS SAMSUNG GALAXY 8. WHEN THE PHONE WAS STOLEN, MR. SOLIS WAS KICKED OUT OF THE VEHICLE AT THE LISTED INCIDENT ADDRESS AND VEHICLE 1 LEFT IN AN UNKNOWN DIRECTION OF TRAVEL. MR. SOLIS WALKED FORM THE INCIDENT ADDRESS TO 4200 SOUTH UNIVERSITY WHERE THE CALL CAME IN FROM. I ALONG WITH OFFICER GALLEGOS DID OBSERVE PHYSICAL INJURY TO MR. SOLIS'S FACE AS WELL AS HIS FINGER. MR. SOLIS WAS OFFERED MEDICAL ATTENTION WHICH HE REFUSED ON SCENE.

I CONDUCTED A BROADCAST TO BE ON THE LOOKOUT FOR THE LISTED SUSPECT AND PRIMARY AGGRESSOR (OSMAN JONAS). OFFICER GALLEGOS PROVIDED TRANSPORT FOR MR. SOLIS NEAR HIS HOME ADDRESS. I MADE CONTACT WITH THE ORIGINAL CALLER FROM WAFFLE HOUSE WHICH ADVISED THEY DID NOT NEED A REPORT OR WANT MR. SOLIS BANNED FROM THE BUSINESS. MR. SOLIS CONTINUED TO TELL THE STORY MULTIPLE TIMES TO OFFICER GALLEGOS WITH MANY INCONSTANCIES IN HIS STORY.

NO FURTHER INCIDENT OCCURRED. MVR AND BWC WERE IN USE.
