### **NARRATIVE**

MS.MORALES THE OWNER OF SOPHIAS COSMETICS STATED AN UNKNOWN WHITE MALE CAME INTO THE STORE. SHE STATED MS. MARTINEZ AND MR. MORALES WERE AT THE FRONT OF THE STORE.
