OFFICERS RESPONDED TO 5023 BASELINE RD (DOLLAR GENERAL) FOR A POSSIBLE SHOOTING. OFFICERS ARRIVED AND LOCATED TWO BLACK JUVENILES ON THE SOUTHEAST SIDE OF DOLLAR GENERAL. OFFICERS OBSERVED THE LISTED VEHICLE WRECKED IN THE FRONT PARKING LOT. OFFICERS APPLIED A TOURNIQUET ON V1 RIGHT LEG FOR A GUNSHOT WOUND. BOTH JUVENILES WERE VERY UNCOOPERATIVE WITH OFFICERS REGARDING THE DETAILS OF THE INCIDENT. OFFICERS SET UP CRIME SCENE TAPE AND ESTABLISHED A CRIME SCENE LOG. OFFICERS SEARCHED THE AREA FOR BULLET CASINGS AND FIREARMS WITH NEGATIVE RESULTS. HENRYETTA PITTMAN ARRIVED ON SCENE AND ADVISED V1 AND J1 WERE HER CHILDREN. MS. PITTMAN DID NOT PROVIDE ANY INFORMATION ON WHAT MIGHT HAVE OCCURRED. SOUTHWEST SUPERVISORS RESPONDED TO THE SCENE. J1 ADVISED OFFICERS WHEN V1 GOT IN THE VEHICLE HE HAD ALREADY BEEN SHOT. OFFICERS FOLLOWED MEMS TO ARKANSAS CHILDREN'S HOSPITAL WITH NON-LIFE THREATENING INJURIES. DETECTIVE WAS NOTIFIED AND RESPONDED TO CHILDREN'S HOSPITAL.
